THE Board of Trade have received from the Secretary of State for Foreign Affairs a copy of a Decree, dated the 11th February last, issued by the President of Costa Rica, granting the following immunities in favour of the mining industry of the Republic :-

ART. 1. exempts from the payment of import or wharfage dues all working implements and other accessories, quicksilver, blasting powder, dynamite, fuses, &c., imported by mining companies for use in mines.

ART. 2. exempts miners and other employés and workmen engaged in mines from military service, and all other public duties.
