The following area (namely),—so much of the township of Rathmell, in the West Riding of the county of York, as lies within the following boundaries, that is to say, on the north commencing at Rathmell Mill, thence by School-lane to Rathmell Village, thence by Settle-road to Liniams Syke at the bottom of Rathmell Brow, thence by the said Syke to the river Ribble ; on the east by the river Ribble to Rathmell Beck ; on the south by Rathmell Beck to junction of Hollow Gill Beck, thence by the said Beck to a point where it joins Knowles Reaker Pasture ; and on the west by the east fences of fields known as Knowles Reaker and High Meadow, thence by the north fence of a field known as Barn Shaw, and thence by the west fence of Low Gill Pasture and Wood to the starting point,—which was declared by Order of Council dated the third day of May, one thousand eight hundred and eighty-two, to be an area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that area shall, as from the commencement of this Order, cease to be an area infected with foot-and-mouth disease.

Aspinal Tobin to Hooton Toll Gate, a lane known as Hooton Green to Hooton Cottages, the boundary fence between lands in the occupation of Richard Littler to Hooton Church, the boundary fence on the south side of Hooton Park dividing the Park from lands

in the occupation of Joseph Howard and James Kellet to the river Mersey, and from the river Mersey the boundary fence of Hooton Park to Chester-road, and (2.) so much of the township of Siddington, in the county of Chester, as lies within the following boundaries, that is to say, Siddington Old Toll Bar site along Congleton-road to and along Occupation-road by Enoch Massey's farm, Marton to Marton brook, the permanent fence between William Slock's and Thomas Adshead's farms, across Blackdair-lane to Old Mere Wood side to Congleton-road and Old Toll Bar aforesaid,—which were declared by Order of Council dated the fifth day of April, one thousand eight hundred and eighty-two, to be areas infected with foot-and-mouth disease, are hereby declared to be free from foot-and-mouth disease, and those areas shall, as from the commencement of this Order, cease to be areas infected with foot-and-mouth disease.
