HINGHAM FAIRS.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices of the Peace for the county of Norfolk, acting in and for the Petty Sessional District of Forehoe, in the same county, that three several Fairs have been annually held at Hingham, within the said Petty Sessional Division of the said county, on the 7th day of March, Whit Tuesday, and the 2nd day of October, respectively, and that it would be for the convenience and advantage of the public that the said Fairs should be abolished:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly published in pursuance of "The Fairs Act, 1871:"

And whereas, on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fairs should be abolished:

And whereas the Right Honourable John, Earl of Kimberley, as lord or owner of the said Fairs, and the tolls thereof, has consented in writing that the said Fairs should be abolished:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fairs which have been annually held at Hingham as aforesaid shall be abolished as from the date of this Order.

TRUMPINGTON FEAST.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices of the Peace of the Petty Sessional Division of Cambridge, in the county of Cambridge, that a Fair, commonly known by the name of "Trumpington Feast," has been annually held at Trumpington, in the county of Cambridge, on the Feast of St. Peter, being the 29th day of June, and two following days, and that it would be for the convenience and advantage of the public that the said Fair should be held on a less number of days than those on which such Fair is used to be held (to wit) on one day only, such day to be the first day of the Fair, namely, the 29th day of June, unless and except the said 29th day of June happen to fall on a Sunday, in which case such day to be the Saturday immediately preceding the 29th day of June:

And whereas notice of the said representation, and of the time when I should take the same into consideration, has been duly given to the Justices acting in the Petty Sessional Division of Cambridge, in the county of Cambridge, within which division the Fair in question is held, and otherwise published in pursuance of "The Fairs Act, 1873:"

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the number of days for the holding the said Fair should be altered as proposed:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1873," do hereby order that the number of the days for the holding of the Fair which has been annually held at Trumpington, in the county of Cambridge, should be altered, and that instead of being held as aforesaid,
