

Cartwright, Blankney, and Henry Paddison, Scopwick, to the farm buildings of the said Henry Paddison at Scopwick Lodge on the west, and Scopwick Lodge-road the Fox Hills to the arable fields first-mentioned on the south.

(12.) So much of the parishes of Caythorpe, and Fulbeck, in the Parts of Kesteven, Lincolnshire, as lies within the following boundaries, that is to say, Fulbeck-road, the highway leading from Leadenham to Sleaford, and an arable field in the occupation of Richard Bestall, Byards Leap, to the Cranwell Lodge-road on the north, the said Cranwell Lodge-road and Gorse-lane on or towards the east, Caythorpe Heath-road to Henry Barnes cottages on the south, and an imaginary line from the said Henry Barnes cottages to the Foreman's house at F. M. Pogson's farm premises, Caythorpe Heath, thence by corn-fields to Henry Burt's farm buildings, Fulbeck, and a grass field to Fulbeck-road aforesaid on the west.

(13.) So much of the parish of Metheringham, in the Parts of Kesteven, Lincolnshire, as lies within the following boundaries, that is to say, Blankney-lane from Blankney cross-roads to the Great Northern and Great Eastern Railway on the south, the Great Northern and Great Eastern Railway on the west, the Metheringham Fen-lane to the Old Carr Dyke on the north, and the said Old Carr Dyke, an arable-field and a corn-field in the occupation of Henry Chaplin, Esquire, M.P., and the Fox Cover plantation and the Metheringham Moor-lane to the Blankney cross-roads aforesaid.

(14.) So much of the parishes of Horbling, Billingborough, and Threckingham, in the Parts of Kesteven, Lincolnshire, as lies within the following boundaries, that is to say, the Great Northern Railway on the east, Falkingham-road to Madam-lane on the south, Madam-lane to Holland-road on the west, and Holland-road to the Great Northern Railway on the north.

(15.) So much of the parish of Metheringham, in the Parts of Kesteven, Lincolnshire, as lies within the following boundaries, that is to say, Green Man bridle-road to Bloxholm-road on the south, Bloxholm-road to Dunston Heath-lane on the west, Dunston Heath-lane to Lincoln and Sleaford low-road on the north, and Lincoln and Sleaford low-road to Green Man bridle-road aforesaid on the east.

*Norfolk.*—The parishes of Wiggshall St. Mary the Virgin, Wiggshall St. Germans, and Tilney-cum-Islington, in the county of Norfolk.

*Northamptonshire.*—The parishes of Barby, and Kilsby, in the county of Northampton.

*Nottinghamshire.*—(1.) Within the following boundaries, that is to say, the river Trent on the south from Barton Boat in the county of Nottingham to and including a field known as Curzens Meadow at Long Eaton in the county of Derby in the occupation of John Shepperd, by a fence to Long Meadow-lane crossing the Midland railway to Clays Works, and on the east side of the Erewash railway, on the west to a point where the railway crosses the river Erewash into the county of Nottingham, on an occupation-road by John Hallam's farm in the parish of Toton, on the north to the Stapleford and Toton-road by a stream of water to the Nottingham-road by Moor Wood, by a fence in Harlys Field, on the east to a road leading to Attenborough by a fence dividing Mr. Holbrook's and Mr. Handburry's land and Mr. Holbrook's and Mr. Morriss's by a wire fence down to Barton Boat.

(2.) So much of the parishes of Attenborough, and Toton, in the county of Nottingham, as lies within the following boundaries, that is to say, on the west by a road from Barton Boat to Toton village, from thence along the Long Eaton and Nottingham-road to Chilwell brick-yard, along Bramcote-lane, on the north by Chilwell boundary fence to the Hop Pole Inn, on the east by the said boundary fence to the river Trent, on the south crossing the river Trent to Barton Wood, and along the Wood side to Barton Boat aforesaid.

*Shropshire.*—(1.) So much of the parish of Baschurch, in the county of Salop, as lies within the following boundaries, that is to say, the water-course from Walford Heath to Fenemere brick-yard, thence the boundary fence which divides T. Slaney Eyton's property to the highway leading from Merrington Green to Walford Heath water-course aforesaid.

(2.) So much of the parish of Chetwynd, in the county of Salop, as lies within the following boundaries, that is to say, the turnpike-road from Blue House to Canal Bridge, Chetwynd End, thence by Water-lane to Vineyard-road, along the boundary of the counties of Stafford and Salop by Meertown brook, thence to Masons-place, and thence by foot-road to Blue House aforesaid.

(3.) So much of the parishes of Childs Ercall, and Stoke upon Tern, in the county of Salop, as lies within the following boundaries, that is to say, the highway leading from the post office at Childs Ercall to Eaton village, thence the highway from Eaton to Ollerton village, and the highway from Ollerton to the post office at Childs Ercall aforesaid.

(4.) So much of the parish of Chetwynd, in the county of Salop, as lies within the following boundaries, that is to say, the highway at Pilson river bridge, then the highway from Pilson river bridge to the Chester and London main-road, then the Chester and London main-road to Chetwynd Furs, then the foot-road from Chetwynd Furs to Pickstock village, then the highway from Pickstock village to Flash brook, then the highway from Flash brook to Whitley ford river bridge, then the river Lanco from Whitley ford river bridge to the river Mase at Chetwynd park, then the river Mase to Pilson river bridge.

(5.) So much of the parish of Forton, in the county of Stafford, and of the township of Chetwynd Aston, in the county of Salop, as lies between the following boundary, that is to say, the main-road from Newport to Coley Mill, Moreton brook, the Shropshire Union Railway, and the brook which runs from near Chetwynd Aston village to the main-road aforesaid.

(6.) So much of the parish of Forton, in the county of Stafford, and of the parish of Newport and the township of Chetwynd Aston, in the county of Salop, as is bounded by the main-road from Coley Mill to Newport, Tau-house-lane, the Shropshire Union Canal, Meer-town brook, Aqualate Meer, and Moreton brook.

*Staffordshire.*—(1.) So much of the parish of Swinnerton, in the county of Stafford, as lies on the western side of the highway from Millstone Green through Acton village to Whitmore.

(2.) So much of the parish of Whitmore, in the county of Stafford, as lies on the northern
