which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint James situate in the tything of Holt as aforesaid, and that the same should be named 'The District Chapelry of Saint James, Holt.'

"And with the like consent of the said George Bishop of the said diocese of Salisbury (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages baptisms, churchings, and burials should be solemnized or performed at the said church of Saint James situate in the tything of Holt as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being : Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint James Holt, being :-

"All that part of the parish of Wimborne Minster in the county of Dorset and in the diocese of Salisbury (comprising the district or tything of Holt) which said part of such parish is bounded on the south-west and on part of the south-east by an imaginary line commencing at the point where the boundary which divides the parish of Hinton Parva otherwise called or known as Stanbridge in the said county of Dorset and in the diocese of Salisbury aforesaid from the parish of Wimborne Minster aforesaid crosses the turnpike-road leading from Cranborne to Wimborne Minster and extending thence that is from the saidparish boundary southward along the middle of the said turnpike-road for a distance of sixty-three chains or thereabouts to its junction, at or near to the house called or known as Clapgate, with the road leading to Cole Hill and extending thence south-eastward along the middle of the last-described road for a distance of seventy-eight chains or thereabouts to its junction with Longlane and extending thence north-eastward along the middle of the last-named lane for a distance of seventy-three chains or thereabouts to a point at the junction of the same lane with the road leading from Cole Hill aforesaid towards Holt Green opposite to the western end of the fence or watercourse which divides the close numbered 815 upon the tithe commutation map of the said parish of Wimborne Minster and upon the map bereunto annexed from the close numbered 632 upon the same maps and extending thence first south-eastward and then eastward to and along the said fence or watercourse for a distance of eleven chains or thereabouts to the boundary at the eastern end of the same fence or water course which boundary divides the said parish of Wimborne Minster from the parish of Hampreston in the county and diocese aforesaid all which hereinbefore described portion of the

said parish of Wimborne Minster is bounded upon the remaining sides other than upon the southwest and the part of the south-east as aforesaid that is to say upon the remaining part of the south-east, upon the east upon the north-east and upon the north-west as follows upon the remaining part of the south-east by the said parish of Hampreston and by a certain detached portion of the parish of Chalbury in the county and diocese aforesaid, upon the east by a certain detached portion of the parish of West Parley in. the said county and diocese, upon the north-east. partly by a certain detached portion of the parish of Gussage All Saints, partly by the parish of Horton both in the county and diocese aforesaid. and partly by the parish of Chalbury aforesaid, and upon the north-west partly by the parish of Hinton Martell in the same county and diocese and partly by the parish of Hinton Parva otherwise called or known as Stanbridge aforesaid.

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Salisbury.

WHEREAS the Local Board of Health of the district of Walsoken, in the county of Norfolk, have (under the provisions of an Act passed in the Session of Parliament held in the twentieth and twenty-first years of Her Majesty's reign, intituled "An Act to amend the Burial Acts") presented a petition stating that the district of Walsoken aforesaid is co-extensive with and consists exclusively of the parish of Walsoken, for which parish it is proposed to provide a burial ground; that no Burial Board has been appointed for the said parish of Walsoken, or for the said district of Walsoken; that an Order in Council has been made for closing, with certain exceptions, the churchyard of the said parish of Walsoken, and praying that the said Local Board may be appointed a Burial Board for the district of such Local Board:

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such petition, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the fourteenth day of August, one thousand eight hundred and eighty-two.

And Her Majesty is further pleased to direct that this Order be published in the London Gazette, and in one of the newspapers usually circulating in the district of the Local Board aforesaid, one month at least before the said four-teenth day of August, one thousand eight hundred and eighty-two.
