THE following Statutes made by the Governing Body of University College, Oxford, on the 18th day of June, 1832, have been submitted for the approval of Her Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions contained in the Universities of Oxford and Cambridge Act, 1877.

Exparte the Master and Fellows of the College of the Great Hall of the University, commonly called University College in Oxford.

A STATUTE to amend a Statute framed by the Commissioners appointed under the Universities of Oxford and Cambridge Act, 1877 (40 and 41 Vic., c. 48) in relation to the College of the Great Hall of the University, commonly called University College, in the University of Oxford, duly made at an Extraordinary General Meeting of the Governing Body of the said College, specially summoned for this purpose, held on the 13th day of June, 1882, and passed at such meeting by the votes of the whole number of persons present and voting, and submitted for the approval of Her Majesty in Council.

Whereas by Statute III 13, framed by the Commissioners under the Universities of Oxford and Cambridge Act, 1877 (40 and 41 Vic., c. 48), in relation to University College in the University of Oxford, they enacted as follows: "There shall always be at least two unmarried Fellows, being Prælectors or Tutors, resident in the College during the usual College terms;" and similarly by Statute IV 2, framed by the same Commissioners in relation to the said College, they enacted as follows: "There shall be resident in the College at least three officers, exclusive of the Master, of whom one shall be the Dean and the other two shall be, in accordance with the provisions of the Statute III 13, Prælectors or Tutors who are unmarried Fellows."

And whereas it appears to us, the Masters and Fellows of the said College (being the Governing Body thereof), that these enactments requiring that there shall be resident in the College at least two Prelectors or Tutors who are unmarried Fellows, unnecessarily and injuriously restricts the choice of the College as to Prelectors or Tutor Fellows, and that the object of these enactments, namely, that there shall be resident in the College a sufficient number of Fellows duly qualified to take part and actually taking part in the work of discipline, instruction, and education may be better served in another way.

We, the said Master and Fellows of the said College, do hereby, in exercise of the powers given us by the 54th section of the said Act, and by Statute XI, framed by the said Commissioners appointed by the said Act in relation to the said College, alter and amend Statute III 13, and Statute IV 2, as hereinbefore set out by omitting in them, and in each of them, the word "unmarried" before the word 'Fellows."

the Great Hall of the University, commonly called University College, in the University of Oxford, duly made at an Extraordinary General Meeting of the Governing Body of the said College, specially summoned for this purpose, held on the 13th day of June, 1882, and passed at such Meeting by the votes of the whole number of persons present and voting, and submitted for the approval of Her Majesty in Council.

Whereas the Statutes framed for University College, in the University of Oxford, by the Commissioners appointed under the Universities of Oxford and Cambridge Act, 1877 (40 and 41 Vic., c. 48), enact in Statute III, 10, regulating the election of Clerical Fellows as follows:—

"If at the time of holding an election to a " Fellowship there shall be no Fellow, actual "or under Probation, who is a Priest or " Deacon of the Church of England, and who " is willing to reside and serve the College if " appointed as Chaplain, and qualified to give "religious instruction within the College, if " required so to do, the Master and Fellows "shall elect, either by examination or under "the provisions of Clause XI (a) of this "Statute, a person who shall in their opinion " be not only fit to be a Chaplain of the Col-"lege, but also eminently qualified to give religious instruction to its members in "statu pupillari, and to be a Fellow of the " College as a place of religion, learning, and " education."

And whereas it appears to us, the Master and Fellows of the said College, that the purpose of the Statute, namely the efficient performance by a member of the Governing Body of the duty of Chaplain, and the religious instruction of the members of the College, will be fully secured by the appointment to the office of Chaplain of the Master of the College if in Holy Orders and willing to accept the office, while the general educational objects of the College may often be advanced by an additional opportunity for using unrestricted choice in the election of a Fellow.

We, the Master and Fellows of the said College, do hereby, in exercise of the powers given us by the 54th section of the said Act, and by Statute XI framed by the said Commissioners appointed by the said Act in relation to the said College, alter and amend Statute III 10 as hereinbefore set out, by substituting for the words "there shall be no "Fellow actual or under probation" the words "there shall be among the Master and Fellows "no person."
