Whitehall, June 26, 1882.

THE Queen has been pleased to grant unto Charlotte Denison, Viscountess Ossington, widow and relict of John Evelyn Denison, Viscount Ossington, deceased, and eldest surviving daughter of William Henry Cavendish Bentinck-Scott, fourth Duke of Portland, and sister and coheir of William John Cavendish Bentinck-Scott, fifth Duke of Portland, both also deceased, Her Royal licence and authority that she may, in compliance with a clause contained in a deed of disposition, bearing date the third day of August, one thousand seven hundred and ninety-five, made by Henrietta, Duchess of Portland (then Henrietta Scott), the mother of the said Charlotte; Viscountess Ossington, assume and bear the surname of Scott in lieu and instead of that of Denison, and bear the arms of Scott quarterly with those of her paternal family of Bentinck and Cavendish; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
