1. The declaration described in the Schedule to this Order, made by the Local Authority for the county of Berks, declaring the existence of foot-and-mouth disease at the place therein mentioned, is hereby cancelled, and the infected Place thereby declared shall, as from the commence-

ment of this Order, cease to be a Place infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the third day of September, one thousand eight hundred and eighty-two.

#### (PLEURO-PNEUMONIA.)

**A**T the *Council Chamber, Whitehall*, the 2nd day of *September, 1882.*

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Area described in the Schedule to this Order, except the lines of railway within that Area as far as those lines are used or required for the transit of cattle through that Area, without untrucking, is hereby declared to be an Area infected with pleuro-pneumonia.

2. No market, fair, exhibition, or sale of cattle shall be held in the said Area except with the licence of the Privy Council.

3. This Order shall take effect from and immediately after the fourth day of September, one thousand eight hundred and eighty-two.

proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.

#### (PORT OF FALMOUTH.)

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Falmouth, in the county of Cornwall, as a foreign animals wharf :

All that piece of land within the borough of Penryn, in the county of Cornwall, situate between Commercial-road and the Penryn River, and included within a line commencing at a point one hundred and nineteen feet or thereabouts north-west of the easternmost corner of the New Quay on the said Penryn River, thence at right angles in a south-westerly direction for a distance of one hundred and forty feet or thereabouts to Commercial-road, thence in a north-westerly direction along the north-east side of Commercial-road for a distance of one hundred and nine feet or thereabouts, thence in a north-easterly direction for a distance of one hundred and two feet or thereabouts to the water's edge of the said Penryn River, thence in a south-easterly direction along the water's edge of the Quay wall of the said Penryn River for a distance of one hundred and ten feet or thereabouts to the point first above-mentioned, all which space is coloured pink on the plan of the said foreign animals wharf deposited for the purposes of this Order at the Privy Council Office, a copy of which is deposited at the office of the Town Clerk of the borough of Penryn.
