(FOOT-AND-MOUTH DISEASE.)

AT the Council Chamber, Whitehall, the 18th day of October, 1882.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twentieth day of October, one thousand eight hundred and eighty-two.

SCHEDULE.

An Area comprising so much of the parish of Hickling, in the county of Nottingham, as lies within the following boundaries, that is to say, from Robert Collishaw's house in Hickling village along a footpath to Lambs Barn, from Lambs Barn along a bridle-road to Kinoulton-road, along the south side of Kinoulton-road to the Neville Arms, thence along the west side of the highway to Robert Collishaw's house in Hickling village aforesaid.

An Area comprising so much of the parishes of Weeford, and Shenstone, in the county of Stafford, as lies within the following boundaries, that is to say, from Weeford Church, thence the foot-road leading through Weeford Park to the London-road, thence the foot-road by Weeford Mill leading to the Little Hay-road, thence the Little Hay-road to Shenstone Park Lodge, thence the road leading through Shenstone Park to the Birmingham-road, thence the Birmingham-road to Shenstone Cross-roads, and thence the road by Shenstone Mill leading to Weeford to Weeford Church aforesaid.

(SWINE-FEVER.)

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—the whole of the parish of Stewkley, except the hamlet of Littlecote, in the county of Buckingham,—which was declared by Order of Council dated the twenty-sixth day of July, one thousand eight hundred and eighty-two, to be an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the nineteenth day of October, one thousand eight hundred and eighty-two.
