Stream on or towards the south, and the highroad from Norwich to Aylsham on or towards the west; (5.) the Hundreds of East and West Flegg and the southern part of the Happing Hundred, which Area is bounded on the south by the borough of Great Yarmouth and the river Bure, on the west by the river Bure, the river Ant, Barton Broad, and the Dyke leading from Barton Broad to Stalham, on the north by Sutton Broad, and the boundaries between the parishes of Sutton and Catfield and between Hickling and Catfield by Hickling Broad, Whitesles, Heigham Sounds, Kendal Dyke, and the Hundred Stream or Dyke leading to the coast near Winterton Ness, and on the east by the North Sea; (6.) so much of the parishes of Aldeby, and Haddiscoe, in the county of Norfolk, as lies within the following boundaries, that is to say, the road to Burgh St. Peter, the Land-Spring Beck, the Marsh-road beyond Aldeby-station, and the Great Eastern Railway; (7.) the whole of the Hundred of Earsham, in the county of Norfolk; (8.) so much of the parish of Moulton, in the county of Norfolk, as lies to the westward of the road leading from Freethorpe to Beighton; (9.) so much of the parishes of Mundham, Loddon, Sisland, and Seething, in the county of Norfolk, as lies within the following boundaries, that is to say, the high-road to Loddon on the south, the road passing Sisland Church to Washingford Bridge on the east, the River Chet on the north, and the road through Seething Fen to Mundham Church on the west; (10.) so much of the parishes of Fritton, and Morningthorpe, in the county of Norfolk, as lies within the following boundaries, that is to say, a branch of the river Tase on the north, the lane from Hempnall to Fritton on the east, Mulberry-lane on the south, and the cross-lane from Morningthorpe to Boyland Hall on the west; (11.) so much of the parishes of Morningthorpe, and Hardwick, in the county of Norfolk, as lies within the following boundaries, that is to say, the lane from Stratton Wood Green to Shelton on the north, the lane leading from Shelton to Hardwick by Austins-lane on the east, Wood-lane on the south, and Tyrrells Wood and Crow Green-lane on the west; and (12.) so much of the parish of Haddiscoe, in the county of Norfolk, as lies within the following boundaries, that is to say, the Haddiscoe Dam on the north and west, the river Waveney on the east, and the Marsh-road crossing the Railway and in a line drawn to the river Waveney on the south,—are hereby extended so as to include the Area described in the First Schedule to this Order, and the Area described in the First Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. Each of the Areas described in the Second Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

3. This Order shall take effect from and immediately after the eighth day of November, one thousand eight hundred and eighty-two.

An Area comprising so much of the parish of Runton, in the county of Norfolk, as lies within the following boundaries, that is to say, the road leading from Sherringham to Cromer on the north, the road leading from Holt to Cromer on the south, Davy Hill and the road leading from Felbrigg to Runton on the east, and Runton Woods and the road leading from Gresham to West Runton on the west.
