#### SCHEDULE.

An Area comprising so much of the parishes of Burton-Joyce, and Bulcote, in the county of Nottingham, as lies within the following boundaries, that is to say, the highway leading from Burton-Joyce to Lowdham from the Burton Police Station to Alveys Gunthorpe farm on the south, and from Alveys Gunthorpe farm by the Bulcote Hill farm boundary fence to the Burton Police Station aforesaid on the west, north, and east.

#### SCHEDULE.

An Area comprising so much of the townships of Little Habton, and Great Barugh, in the North Riding of the county of York, comprised within the following boundaries, that is to say, the Barugh and Newsham Bridge-road commencing at the new Blacksmith's shop at Barugh to Intake-lane on the east, Intake-lane and the fence on the south side of Middle North field and Fare North field in the occupation of William Pybus to the river Seven on the south, the river Seven on the west, and from the river Seven by a fence on the south side of two fields in the occupation of Henry Mallory known as the Little and Great Green fields, the fence on the south side of Pickering's Paddock and garden, thence by the garden-wall to the village-street, and thence by the village-street to the new Blacksmith's shop aforesaid on the north.

1. The following Area (namely),—so much of the townships of Haslington, and Crewe, in the county of Chester, as lies within the following boundaries, that is to say, along the Sandbach-road commencing at Brereton's Smithy in Haslington village to Winterly Mill, thence along the highway to Samuel Sutton's Bridge House farm, thence along the highway past Oakhanger Hall and John Sutton's to Buttertons-lane, thence along Buttertons-lane by Barthomley-road to Crewe Park, and thence along the highway to Brereton's Smithy in Haslington village aforesaid, —which was declared by Order of Council dated the twenty-seventh day of September, one thousand eight hundred and eighty-two, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the sixteenth day of November, one thousand eight hundred and eighty-two.

The following Places declared by Order of Council to be Places infected with foot-and-mouth disease (namely),—(1.) all the lands, buildings, and premises situate at Edingale, in the parish of Croxall, in the county of Derby, in the occupation of William Upton; (2.) all the lands, buildings, and premises situate in the parish of Walton-upon-Trent, in the county of Derby, in the occupation of Humphrey James; and (3.) all the lands, buildings, and premises situate in the parish of Walton-upon-Trent, in the county of Derby, in the occupation of Samuel Smith;—are hereby declared to be free from foot-and-mouth disease, and those Places shall, as from the commencement of this Order, cease to be Places infected with foot-and-mouth disease.
