garden in the occupation of Mr. Rudd on the east, a certain house and garden at present unoccupied on the south, and a certain house lately in the occupation of Arthur Wells deceased on the west.

(3.) So much of the parish of Sneinton, in the borough of Nottingham, as lies within the following boundaries, that is to say, certain cottage-gardens on the north, certain land in the occupation of Messrs. Birkin and Scoofield on the east, certain household property on the south, and certain land belonging to Earl Manvers on the west.

(4.) So much of the parishes of Ratcliffeon-Trent, Carlton, and Colwick, in the county of Nottingham, as lies within the following boundaries, that is to say, the Stoke Dyke and boundary fence from Colwick Good's Yard to the river Trent on the east, from the end of Stoke boundary fence by the river Trent to the south corner of George Neale's field on the south, from thence by a straight line across to Colwick Passenger Station on the west, and from thence by the Great Northern Gedling line to the Stoke Dyke on the north.

line to the Stoke Dyke on the north.

(5.) So much of the parish of Clifton, in the county of Nottingham, as lies within the following boundaries, that is to say, the highway leading from Wilford to Barton on the south, the occupation-road at the top of Mr. Allen's field leading from the Barton highway to the river Trent on the west, the river Trent to the end of Clifton Grove on the north, and from the end of Clifton Grove along Mr. Spencer's Brick-yard field fence to the Barton highway on the east.

(6.) At Wellow, in the county of Nottingham, comprised within the following boundaries, that is to say, the high-road leading from Newark to Worksop on the south, a lane leading from the said high-road to Jordan Castle farm on the west, the fence of Wellow Park on the north, and the private-road leading from Laxton to Ompton on the east.

(7.) At Carlton, in the county of Nottingham, comprised within the following boundaries, that is to say, the upper village of Carlton on the north, Wigthorpe-lane on the south, Forestlane (leading from Carlton to the Blythe-road) on the east, and the Carlton and Worksop-road on the west.

(8.) At Tuxford, in the county of Nottingham, comprised within the following boundaries, that is to say, the highway from Tuxford to Bevercotes on the north, the highway from Egmanton to Kirton on the south, the highway from Kirton to Willoughby on the east, and Farley's-lane including Saint John's College Low farm on the west.

(9.) So much of the parishes of Mansfield, and Mansfield Woodhouse, in the county of Nottingham, as lies within the following boundaries, that is to say, a line from the Bridge near Bath Mill in Mansfield along the footpath to Old Mill-lane, across such lane, along Stintonlane to Rushpool farm, thence along the road to Midworth's Plantation, from there to Clipstone-road at Walker's Plantation, across Newlands-road to Norman's Wood, thence along Eakring-road to Sandy-lane, and along Sandylane to the Bridge near Bath Mill in Mansfield aforesaid.

(10.) At South Muskham, in the county of Nottingham, comprised within the following boundaries, that is to say, on or towards the south the parish boundary fence leading from Debdale Bar to Hopping Hill-lane, on or towards

the west by Hopping Hill-lane and an imaginary line from the end of that lane to Walner Wood, on or towards the north by an imaginary line from Walner Wood to Hopyard-lane, and on or towards the east from Hopyard-lane to Debdale Bar aforesaid.

(11.) At Maplebeck, in the county of Nottingham, comprised within the following boundaries, that is to say, on or towards the north by a brook known as the Beck, on or towards the east by Duke's Wood, on or towards the south by a lane known as Moor-lane leading from the Maplebeck-road to Winkburn, and on or towards the west by a brook known as Hagley's Dumble.

(12.) At Langford, in the county of Nottingham, comprised within the following boundaries, that is to say, on or towards the north the Midland Railway from Newark to Lincoln, on or towards the east Langford Church-lane and an imaginary line from the end of Langford Church-lane to the Foss-road leading from Newark to Lincoln, on or towards the south the said Foss-road, and on or towards the west Thoroughfare-lane to Winthorpe School and a straight fence leading from Winthorpe School to the Midland Railway.

(13.) At Alverton, in the county of Nottingham, comprised within the following boundaries, that is to say, the Great Northern Railway on the south, Bottesford-road leading from the Great Northern Railway to Spa-lane in the parish of Orston on the west, Spa-lane leading from Bottesford-road to Alverton on the north, and a certain fence known as the boundary fence running from Alverton to the Great Northern Railway on the east.

(14.) So much of the parish of Sibthorpe, in the county of Nottingham, as lies within the following boundaries, that is to say, on or towards the south by Longhedge-lane leading from White Cross to the Four-lane Ends near Hawksworth, on or towards the east by Sibthorpe-road leading from Hawksworth to Sibthorpe and the Back Dyke as far as the Hunting Bridge, on or towards the north by an imaginary line from the Hunting Bridge to Deadwong-laue Bridge and a straight line from the latter Bridge to White Cross, and on or towards the west by Longhedge-lane.

towards the west by Longhedge-lane.

(15.) So much of the parish of Mansfield, in the county of Nottingham, as lies within the following boundaries, that is to say, the Mansfield and Southwell line of Railway from the Nottingham-road to the Southwell-road, the Southwell-road from the Railway Bridge to Lyndhurst-lane, Lyndhurst-lane through Mansfield Wood to the Old Turnpike-road, the Old Turnpike - road from Lyndhurst-lane to the Nottingham-road, and the Nottingham-road from the Old Turnpike to the Railway Bridge.

(16.) At Orston, in the county of Nottingham, comprised within the following boundaries, that is to say, from Alverton boundary to Bottesford Crossing on the Great Northern Railway on the east, Bottesford-lane to Gillotts farm on the south, Lordship-lane, Spa-lane, and Milllane to Flawborough boundary in Long Edgelane, and Flawborough boundary fence to Alverton-road on the west, and Alverton-road to Alverton boundary aforesaid on the north.

Rutland.—(1.) So much of the parishes of Egleton, and Hambleton, in the county of Rutland, as lies within the following boundaries, that is to say, the road leading through the open fields from Egleton village to Hambleton from the first gate across the said road in the parish of
