A PROCLAMATION.

VICTORIA, R.

WHEREAS Our Parliament stands prorogued to Thursday, the fifteenth day of February, one thousand eight hundred and eighty-three, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare Our Royal will and pleasure that the said Parliament shall, on the said Thursday, the fifteenth day of February, one thousand eight hundred and eighty-three, assemble and be holden for the dispatch of divers urgent and important affairs: and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said Thursday, the fifteenth day of February, one thousand eight hundred and eighty-three.

Given at Our Court at Osborne House, Isle of Wight, this twenty-eighth day of December, in the year of our Lord one thousand eight hundred and eighty-two, and in the forty-sixth year of Our reign.
