Grendon and Warton-lane to the Bridge over | the Orton brook aforesaid.

(8.) At Grendon, near Atherstone, in the county of Warwick, comprised within the following boundaries, that is to say, Watling Streetroad from Grendon-road corner to where it meets Whillington-lane at the top of Archers Hill, Whillington-lane to the London and North-Western Railway, the London and North-Western Railway to the Bridge over Grendonroad, and Grendon-road to Watling Street-road aforesaid.

**Vorkshire** (*East Riding*).—(1.) So much of the parish of Grindall, in the East Riding of the county of York, as lies within the following boundaries, that is to say, the highway leading from North Burton to Boynton on the east and south, and a quickwood fence dividing a grass field and tillage fields on the north and west sides in the same occupation and known by the name of the Back Garth.

(2.) So much of the parish of Hunmanby, in the Dickering petty sessional division, in the East Riding of the county of York, as lies within the following boundaries, that is to say, the highway leading from Hunmanby to Rudston on the east, certain quickwood fences dividing tillage fields from the grass field known as Cowpasture, in the occupation of Hannah Lowish, on the north, south, and west.

- Yorkshire (North Riding).—So much of the townships of Kingthorpe, and Farmanby, in the North Riding of the county of York, as lies within the following boundaries, that is to say, the Thornton and Lockton-road commencing at Brewsters Gate Horkendale Slack to the Little Plantation on the west, Little Plantation to the Warren Wall on the north, the Warren Wall on the east, and a quickwood fence from the Warren Wall on the south side of the seed field known as The Eleven Acres in the occupation of Simpson Allinson, and by Brewsters fence to Horkendale Slack.
- Forkshire (West Riding).—(1.) At Gateforth, in the West Riding of the county of York, comprised within the following boundaries, that is to say, on the north by Hillam-lane to Gateforth House, on the east Gateforth House to Barry's Lodge, on the south Barry's Lodge in a line to the Aire and Calder Canal, and on the west the Aire and Calder Canal in a line to Hillamlane aforesaid.

(2.) At Crofton, in the West Riding of the county of York, comprised within the following boundaries, that is to say, the Wakefield and Pontefract-road from the Cock and Crown Inn at Crofton to West-lane on the north, West-lane, Castle-fence, and Spring-lane to Santingley-lane on the east, and the highway from Spring-lane through Crofton village and Cock-lane to the junction of the roads at the Cock and Crown Inn at Crofton aforesaid on the south and west.

(3.) At Tockwith, in the West Riding of the county of York, comprised within the following boundaries, that is to say, commencing at a gate leading into a certain turnip field in the occupation of John Ripley situate at Tockwith Town End adjoining the York and Tockwith-road, thence running east to Wilstroplane End, thence up the said lane in a northerly direction to Mr. Brogden's fence near Syke drain, thence in a westerly and southerly direction alongside the said drain to the said York and Tockwith-road, and thence in an easterly direction to the gate aforesaid.

## (SWINE-FEVER.)

THE following Areas are now Areas Infected with Swine-Fever under the above-mentioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of swine through those Areas, without untrucking):--

- Buckinghamshire.—The whole of the parishes of Casile Thorpe, Hanslope, and Stoke Goldington, and including all detached portions of the same or other pärishes in the county of Buckingham, and extra-parochial places in the same county which are surrounded wholly or in part by the before-named parishes or any or either of them.
- Warwickshire.—In the borough of Birmingham, in the county of Warwick, comprised within the following boundaries, that is to say, Vauxhall-road on the north, Northumberland-street on the east, Saint James's-place on the west, and Viaduct-street on the south.
- Willshire.—The petty sessional divisions of Calne, Chippenham, and Malmesbury, in the county of Wilts.
