or perpetual curacy and parish church of Saint Etheldred.

"2. That the limits and boundaries of the said two parishes of Saint Julian and Saint Etheldred are well known and defined and each parish bath its own churchwardens overseers and parish officers.

"3. That according to the last census the population of the said parish of Saint Julian is 1890 and the population of the said parish of Saint Etheldred is 617.

"4. That there is a detached portion of the said parish of Saint Julian lying at a distance from the parish church and contiguous to the said parish of Saint Etheldred which said portion is distant from the said parish church of Saint Julian 363 yards or thereabouts and from the said church of Saint Etheldred 30 yards or thereabouts.

"5. That the population of the said detached portion of the said parish of Saint Julian is estimated at 460.

"6. That the said detached portion of the said parish of Saint Julian is marked No. 1, on the map hereto annexed.

7. That it is proposed to separate the abovementioned detached portion of the parish of Saint Julian from the said parish and unite the same to

the said parish of Saint Etheldred.

"8. That a portion of the said parish of Saint Etheldred marked No. 2 and coloured pink on the said map hereto annexed and containing an estimated population of 220 is proposed to be separated from the said parish of Saint Etheldred and united to the said parish Saint Julian in exchange for the detached portion of the said parish of Saint Julian proposed to be united to the said parish of Saint Etheldred.

"9. That the net annual value of the said rectory of All Saints with Saint Julian is £250 or thereabouts.

"10. That the net annual value of the said vicarage or perpetual curacy of Saint Etheldred is £80 or thereabouts.

"11. That there is no parsonage house belonging to the said rectory of All Saints with Saint Julian.

"12. That there is no parsonage house belonging to the said vicarage or perpetual curacy of Saint Ethelred.

\*13. That the patron of the said rectory of All Saints with Saint Julian is the Reverend Henry Clement Sculthorpe vicar or perpetual curate of Beeley in the county of Derby and the patrons of the said vicarage or perpetual curacy of Saint Etheldred are the Trustees of the Great Hospital, in the city of Norwich.

"14. That the Reverend William Kant Clerk in Holy Orders is the rector of the said rectory and parish churches of All Saints with Saint Julian and the said vicarage or perpetual curacy and parish church of Saint Etheldred is now vacant.

"15. That it appears to me that under the provisions of the Act of Parliament passed in the session holden in the first and second years of the reign of Her present Majesty (chapter 106) entitled 'An Act to abridge the holding of Benefices in Plurality and to make better Provision for the Residence of the Clergy' the said detached portion of the said parish of Saint Julian may advantageously be separated from the said rectory and parish of Saint Julian and be united to the said vicarage or perpetual curacy and parish of Saint Etheldred may advantageously be separated from the said vicarage or perpetual curacy and parish of Saint Etheldred may advantageously be separated from the said vicarage or perpetual curacy and parish of Saint Etheldred and be united to

the said rectory of All Saints with Saint Julian and parish of Saint Julian.

"16. That it is not proposed to alter or vary the patronage of either of the said benefices.

"17. That pursuant to the directions contained in the 26th section of the said Act of Parliament I have drawn up a scheme in writing appended to this representation describing the mode in which it appears to me that the alteration above proposed may best be effected and I do submit the same to your Grace together with the consents in writing of the said Reverend Henry Clement Sculthorpe the patron of the said rectory and parish churches of All Saints with Saint Julian and of the said trustees of the Great Hospital in the city of Norwich the patrons of the vicarage or perpetual curacy and parish church of Saint Etheldred and of the Reverend William Kant the rector of the said rectory and parish church of Saint Julian to the intent that your Grace may if on full consideration and inquiry you shall be satisfied with the said scheme certify the same and such consents by your report to Her Majesty in Council.

"Given under my hand this fourth day of November, 1882. "John T. Norwich.

And whereas the Scheme and Consents referred to in the said Representation are as follows:—

"The SCHEME above referred to.

"1. That the detached portion of the parish of Saint Julian in the city and diocese of Norwich which is marked No. 1 on the map hereto annexed shall be separated from the rectory of All Saints with Saint Julian annexed and the parish of Saint Julian aforesaid and be united to and deemed part and parcel of the vicarage or perpetual curacy and parish of Saint Etheldred in the same city and diocese for ecclesiastical purposes.

"2. That the portion of the parish of Saint Etheldred in the same city and diocese which is marked No. 2 and coloured pink on the map hereto annexed shall be separated from the vicarage or perpetual curacy and parish of Saint Etheldred aforesaid and be united to and deemed part and parcel of the rectory of All Saints with Saint Julian and parish of Saint Julian aforesaid for

ecclesiastical purposes.

"3. That such detached portion of the parish of Saint Julian shall be subject to the same ecclesiastical jurisdiction as the said vicarage or perpetual curacy and parish of Saint Etheldred and the vicar or perpetual curate of Saint Etheldred shall have exclusive cure of souls within the limits of the said detached portion as of the said vicarage or perpetual curacy and parish of Saint Etheldred.

- "4: That except as hereinafter mentioned no alteration shall be made in the endowments of the said rectory of All Saints with Saint Julian and parish of Saint Julian and vicarage or perpetual curacy and parish of Saint Etheldred,
- "5. That such portion of the parish of Saint Etheldred shall be subject to the same ecclesiastical jurisdiction as the said rectory of All Saints with Saint Julian and parish of Saint Julian and the rector of All Saints with Saint Julian shall have exclusive cure of souls within the limits of the said portion as of the said rectory of All Saints with Saint Julian.
- "6. That all the fees and other ecclesiastical dues and payments for marriages churchings burials and other ecclesiastical offices in respect of persons living and dying in the said detached portion of the parish of Saint Julian solemnized and performed within the said church of Saint Ethel-
