

## SCHEDULE.

An Area at Brandon, in the county of Warwick, comprised within the following boundaries, that is to say, the road leading from Brandon to Bretford from Side-Hill Spinny to Bretford village, thence the road leading from Bretford to Wolston to where it is crossed by the London and North-Western Railway, thence the London and North-Western Railway to where it adjoins the river Avon, and thence the river Avon to Side-Hill Spinny aforesaid.

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—so much of the parishes of Witcham, and Mepal, in the Liberty of the Isle of Ely, as lies within the following boundaries, that is to say, the Hundred Feet river on the north, the highway from Witcham to Mepal to the Hundred Feet river on the south and west, and the highway from Witcham to the Hundred Feet river on the east; the said highways not being included in the Area,—which was declared by Order of Council dated the fourteenth day of December, one thousand eight hundred and eighty-two, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-third day of January, one thousand eight hundred and eighty-three.

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—at Littleport, in the Liberty of the Isle of Ely, comprised within the following boundaries, that is to say, on the north and west partly by the Brandon river in the county of Norfolk and partly by the boundary Dyke which separates the farms of H. T. Ludington and William C. Peacock including the farm of the latter, and thence south and east by the outward boundary Dyke of White House farm to George Morton's farm,—which was declared by Order of Council dated the thirteenth day of December, one thousand eight hundred and eighty-two, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

An Area comprising so much of the parish of Alfreton, in the county of Derby, as lies within the following boundaries, that is to say, starting from the Chemical Works on the Canal side at Pye Bridge, by the right along the Canal side to Ironville, thence along the Codnor Park-road to Maltby's Corner (Riddings), by the left along Greenhill-lane to Wolverson's Corner, thence by the right along Greenhill-lane to Lea Brook's Corner, thence to the National Schools (Somercotes), thence by the left down Birchwood-lane, and turning to the right along the footpath leading to the Chemical Works aforesaid.

An Area in the Parts of Lindsey, Lincolnshire, comprising the whole of the land in the parish of Saxelby on the south side of the Fossdyke, and the land in the same parish on the north side of the Fossdyke bounded on the west by the road from Saxelby to Ingleby as far as Mill-lane, on the north by Mill-lane leading from Ingleby-lane to the river Till in part and the boundary line of the parish of Broxholme in other part, on the east by the parish of South Carlton, and on the south by the boundary fence on the north side of Mr. Barker's farm in the parish of Burton.
