The promotion to the rank of Major of Captain J. C. R. Glasgow is antedated to 7th September, 1882, in succession to H. M. Lowry.

Captain Owen Williams to be Major, vice C. Hely, whose promotion has been cancelled. Dated 11th October, 1882.
