The signal, consisting of four circular discs on a mast, is made daily, as follows :-

The discs are placed perpendicularly at 5 minutes before the signal, and fall into a horizontal position at 1h. Om. Os. P.M. Greenwich mean time.

If from any cause the signal fails, a blue flag is hoisted on the same mast, and remains so for one hour.
