And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Rochester.

THE following Statute, made on the 10th day of February, 1883, by the Governing Body of Corpus Christi College, Oxford, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in the Universities of Oxford and Cambridge Act, 1877.

A STATUTE made at a Special Meeting of the Governing Body of Corpus Christi College, Oxford, by a unanimous vote and sealed the 10th day of February, 1883.

This, if approved, will be inserted in lieu of the existing Statute 41 of the Corpus Christi Statutes.

The Dean shall be elected annually from the Fellows, Tutors, Assistant Tutors, and Lecturers of the College. He shall reside within the walls of the College, or in the immediate neighbourhood of the College, during the usual College Terms; and it shall be his duty to exercise a personal supervision over the conduct of the Scholars and Commoners, and generally to assist the President and Vice-President in maintaining the discipline of the College. The Dean shall present Members of the College for their degrees.
