ART. 2. In addition to these import duties, one per cent. ad valorem upon the original value of the invoice will be charged, in order to create a fund for a Statistical Office. Importers, therefore, are under the obligation of presenting to the Customs authorities, when they clear their goods, an original invoice, certified by the Consul of Costa Rica, at the place where the invoice was made, or by two respectable mer-chants in the absence of a Consul.

N.B.—This Consular certificate will come into force sixty days after the promulgation of

the present law.

ART. 3. The duty onexports will be one cent. per quintal, except woods, which will pay one cent. for every ten cubic feet.

ART. 4. This Decree will be submitted to

Congress at its next ordinary Session.

The Customs Tariff referred to in Art. 1 of the Decree can be seen on application at the Commercial Department, Board of Trade.
