brooklet to the river Yore, thence westward up the river Yore to a stone fence on the east of Collierholme farm, thence northward along the said stone fence to the Hawes and Sedbergh turnpike-road to Cotterdale-road End, thence up the Cotterdale-road to Cotter Riggs, thence along a stone fence to Cotter brooklet, from there along the boundary fence of Pry House farm to the West Pit Coal-road on the west, and continuing along the last-named road to the said Bridge in Hardrow village,—which were declared by Orders of Council to be Areas infected with foot-andmouth disease, are hereby declared to be free from foot-and-mouth disease, and those Areas shall, as from the commencement of this Order, cease to be Areas infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twentieth day of March, one thousand eight hundred and eighty-three.
