The following Area (namely),—at Abbey of Paisley, in the county of Renfrew, comprised within the following boundaries, that is to say, the turnpike-road leading from Paisley to Johnstone on the north, the road leading from Elderslie to Glenpatrick on the east and south, and Glenpatrick Burn on the west,—which was declared by Order of Council dated the twelfth day of April, one thousand eight hundred and eighty-three, to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.
