By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Place described in the Schedule to this Order (except the lines of railway within that Place as far as those lines are used or required for the transit of animals through that Place without untrucking) is hereby declared to be a Place infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twelfth day of June, one thousand eight hundred and eighty-three.

SCHEDULE.

A Place comprising the whole of the West Common, in the borough of Godmanchester, in the county of Huntingdon, except such part as has been hurdled off against the road leading from Godmanchester to Huntingdon.

INSTRUMENT substituting the New Church of Saint Iliid, within the ancient Chapelry of Llanulid, otherwise Cray, in the Parish of Devynock, for the Old Church thereof, in the county of Brecon, and Diocese of Saint David's.

To all to whom these presents shall come the Ecclesiastical Commissioners for England send greeting:

WHEREAS a new church has lately been built at Cray, within the ancient chapelry of Llanulid, otherwise Cray, in the parish of Devynock, in the county of Brecon, and in the diocese of Saint David's, and has been consecrated and dedicated to Saint Iliid.

And whereas the Right Reverend William Basil, Bishop of the said diocese of Saint David's, as such Bishop, and the Reverend Rees Evans, Clerk in Holy Orders, the Vicar or Incumbent of the vicarage of the said parish of Devynock, and as such Vicar or Incumbent the patron of the perpetual curacy of the said ancient chapelry of Llanulid; otherwise Cray, and the Reverend William Evans, Clerk in Holy Orders, the Perpetual Curate of the perpetual curacy of the same ancient chapelry, have, by an instrument under their hands, bearing date on or about the twenty-eighth day of April, in the year one thousand eight hundred and eighty-three, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said ancient chapelry of Llanulid, otherwise Cray,

that the said new church of Saint Iliid, situate within such ancient chapelry, should be substituted for the old church, also dedicated to Saint Iliid, of the same ancient chapelry.

Now, therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her present Majesty, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do, by this instrument under our common seal with the consent (testified as hereinafter mentioned) of the said William Basil, Bishop of the said diocese of Saint David's, as such Bishop, and of the said Rees Evans, as such patron as aforesaid, and of the said William Evans, as such perpetual Curate as aforesaid, hereby declare that the said new church of Saint Iliid, situate within the said ancient chapelry of Llanulid, otherwise Cray, and duly consecrated as aforesaid, shall be, and the same is hereby, substituted for the said old church dedicated to Saint Iliid as aforesaid, of the same ancient chapelry, and that such new church shall henceforth be the church of the said ancient chapelry of Llanulid, otherwise Cray, in lieu of the said old church of Saint Iliid, as fully in all respects as if the said new church of Saint Iliid, so hereby substituted, had been originally the church of the same ancient chapelry.

And we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old church dedicated to Saint Iliid as aforesaid of the said ancient chapelry of Llanulid, otherwise Cray, or of or belonging to the perpetual Curate or Incumbent thereof, to the said new church of Saint Iliid (now being, by virtue of these presents, the church of the said ancient chapelry of Llanulid, otherwise Cray), and to the perpetual Curate or Incumbent thereof, and his successors for ever.

In witness whereof to these presents, we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said William Basil, Bishop of the said diocese of Saint David's, has set his hand and affixed his episcopal seal, and the said Rees Evans and the said William Evans have respectively set their hands and affixed their seals this twenty-fourth day of May, in the year one thousand eight hundred and eighty-three.
