

Authority whose Accounts are subject to be audited by a District Auditor, and each of such Highway Districts is partly situated within the said Audit District :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order and Prescribe that it shall, until We otherwise Prescribe, be the duty of the said William Floyd to audit the Accounts of each of the said Highway Boards, and of their Officers, in conformity with the provisions contained in Article 3 of the above cited Order ; and that for the purpose of such Audit the District of each of the said Highway Boards shall be deemed to be within the said Northamptonshire Audit District.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :
