THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Minister at Copenhagen, reporting that vessels arriving from, or having been in communication with, any port in Egypt, or which have taken on board persons from any such vessel, will be subjected to a quarantine of observation in Denmark.

THE Board of Trade have received through the Secretary of State for Foreign Affairs information to the effect that the following measures of quarantine have been adopted by the French Government with respect to vessels arriving from Cyprus, Malta, Egypt, or countries beyond the Isthmus of Suez:—

At ports on the Atlantic or in the Channel,—For all vessels a quarantine of observation accompanied by disinfection. For infected vessels seven days quarantine.

At ports on the Mediterranean, including those in Algeria,—For all vessels seven days quarantine, accompanied by discharge of cargo and disinfection. For infected vessels ten days quarantine, accompanied by most rigorous disinfection.
