thereof now vested in him and his successors as aforesaid and in testimony of such his willingness and in order to express that consent of the Bishop of the diocese which is by the Acts hereinbefore mentioned or by some or one of them made necessary he the said James Colquboun Bishop of Bangor has executed this scheme as hereinafter mentioned.

"And whereas it appears to us that the transfer of the patronage of the said benefice of Llanfairis-Gaer which is hereinbefore mentioned and is hereinafter recommended and proposed will under and in consequence of the circumstances hereinbefore set forth tend to make better provision for the cure of souls in the parish or district in or in respect of which the said right of patronage and advowson arises and exists.

"Now therefore with the consent of the said James Colquhoun Bishop of Bangor (in testimony whereof he the said Bishop has signed this scheme and sealed the same with his episcopal seal) and also with the consent of the Right Honourable and Most Reverend Edward White Archbishop of Canterbury (in testimony of which consent he the said Archbishop has signed this scheme and sealed the same with his episcopal seal) we the said Ecclesiastical Commissioners humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Llanfairis-Gaer now vested in the said James Colquhoun Bishop of Bangor as aforesaid shall be transferred from him the said Bishop and from his successors to the said George William Duff Assheton Smith and his heirs and assigns and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be fully and freely exercised by the said George William Duff Assheton Smith and his heirs and assigns for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bangor.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the ninth day of August, in the year one thousand eight hundred and eighty-three in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirtyseven have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken out of the parish of Gedling in the county of Nottingham and in the diocese of Lincoln.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Gedling which is hereinafter mentioned and described should be constituted a separate district in manner hereinafter recommended and proposed.

"And whereas there is not at present within the limits of the said proposed separate district any consecrated church or chapel in use for the

purposes of Divine worship.

"And whereas by a certain deed of indenture bearing date on or about the second day of August in the year one thousand eight hundred and eightythree and made or expressed to be made under the authority of the New Parishes Acts 1843, 1844 and 1856 or of some or one of them and being under the hands and seals of the Honourable and Reverand Orlando Watkin Weld Forester Canon of York Cathedral and rector or incumbent of the rectory of the said parish of Gelding, and of the Right Honourable Henry Howard Molyneux Earl of Carnarvon the patron of the said rectory of the parish of Gelding aforesaid and of the Right Reverend Christopher Bishop of the said diocese of Lincoln and being also under the common seal of us the said Ecclesiastical Commissioners for England (which deed is intended to be enrolled in the Chancery Division of Your Majesty's High Court of Justice) the said Orlando Watkin Weld Forester as such rector or incumbent as aforesaid did with the consents mentioned in the same deed grant and confirm unto the minister of the district hereinafter recommended to be constituted and intended as is mentioned in the said deed of indenture to be named "The District of Saint Paul Carlton in the Willows" so soon as such minister shall have been appointed and licensed thereto in accordance with the provisions of the hereinbefore mentioned Act and when the said district shall have become a new parish then to the incumbent of the said new parish and to his and their successors the ministers or incumbents thereof for the time being certain pieces or parcels of land and hereditaments (part of the glebe land and hereditaments belonging to the said rectory) situate in the said parish of Gedling and containing together one hundred and fiftyfive acres one rood and thirty-six perches or thereabouts which said pieces or parcels of land and hereditaments are estimated to be of a nett annual value of not less than two hundred and fifty pounds and are particularly described in the said deed and are delineated in the plan drawn in the margin of the same deed.

"And whereas the said pieces or parcels of land and hereditaments have been so granted and confirmed as aforesaid upon the understanding that (such arrangement appearing to us to be expedient) the whole right of patronage of the said proposed district and when such district shall have become a new parish as aforesaid then of the said new parish and of the nomination of the minister or incumbent thereof should be assigned in the manner hereinafter recommended and

proposed.

"Now therefore with the consent of the said Christopher Bisliop of the said diocese of Lincoln (in testimony whereof he has signed and sealed
