Your Majesty in Council bearing date the seventeenth day of March in the year one thousand eight hundred and seventy-four and published in the London Gazette upon the twentieth day of the same month a part of the parish of Charles Plymouth in the county and diocese aforesaid was assigned as a district chapelry to the consecrated church called or known as Charles Chapel situate within the limits of the said parish of Charles Plymouth and the same district chapelry was called 'The District Chapelry of Saint Luke Plymouth.'

"And whereas the said district chapelry of Saint Luke Plymouth has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the said above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Saint Luke Plymouth should be altered by way of extension so that they shall include a further part of the said parish of Charles Plymouth.

"Now therefore with the consent of the Right Reverend Frederick Bishop of the said diocese of Exeter (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of Saint Luke Plymouth shall be altered by way of extension so that they shall include all that part of the said parish of Charles Plymouth which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink and that from and after the day of the same date and without any assurance in law other than such duly gazetted Order the said part of the parish of Charles Plymouth so to be included as aforesaid shall become and be and form part of the said new parish of Saint Luke Plymouth.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of either of them or of any other Act of Parliament

## "The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the new parish of Saint Luke Plymouth in the county of Devon and in the diocese of Exeter being :---

"All that part of the parish of Charles Plymouth in the county and diocese aforesaid which is bounded on the north and on part of the east by an imaginary line commencing upon the boundary which divides the said new parish of Saint Luke Plymouth from the parish of Charles Plymouth aforesaid at the point where James-street is joined by the road called or known as Portlandplace West and extending thence eastward along the middle of the said road for a distance of two chains or thereabouts to its junction with the roadway which leads along the southern side of Portland-square and continuing thence eastward along the middle of the said roadway for a distance of four and a half chains or thereabouts to its junction with the roadway which leads from the eastern side of the same square to Portlandplace East and extending thence southward along the middle of the last-described roadway for a distance of one chain or thereabouts to the boundary at the junction of the same roadway with Portland-place East aforesaid which boundary divides the said parish of Charles Plymouth from the new parish of Saint Luke Plymouth aforesaid all which said hereinbefore described part of the parish of Charles Plymouth aforesaid is bounded upon all other sides other than upon the north and the part of the east as aforesaid, that is to say upon the remaining part of the east upon the south and upon the west by the new parish of Saint Luke Plymouth aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Exeter.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the ninth day of August, in the year one thousand eight hundred and eighty-three, in the words following, that is to say :-

to say :--"We the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen, of the Act of the sixth and seventh years of Your Majesty chapter thirtyseven of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four and of the Act of the twenty-third and twenty-fourth years of Your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken partly out of the parish of Saint Mary Stoke Newington and partly out of the new parish (sometime district chapelry) of Saint Thomas Stamford Hill both in the county of Middlesex and in the diocese of London.
