By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the twenty-first day of September, one thousand eight hundred and eighty-three. *Herbert M. Suft.* 

#### SCHEDULE

An Area in the parish of Holyhead, in the county of Anglesey, bounded on the south by the road leading from Towyn Penrhos towards Llanfawr, on the south-west by the road leading from the Llanfawr-road to Black Bridge where the same joins the Turkey Shore-road, on the north partly by the Turkey Shore-road and partly by the sea, and on the east by the sea.

An Area comprising so much of the parish of Foxton, in the county of Cambridge, as is bounded by the high-road to Cambridge towards the north, by the Offa brook towards the east, by the village-street of Foxton towards the south, and by the highway leading from Foxton village to the Railway-station towards the west.
