(FOOT-AND-MOUTH DISEASE.)

A^T the Council Chamber, Whitehall, the 6th day of October, 1883.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Mnjesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—in the parish of Holbeach, (Holbeach Marsh.) in the petty sessional division of Elloe, in the Parts of Holland, Lincolnshire, comprising the whole of the Lapwater and Leadenhall farms, occupied by Mr. Joseph Ward, in Holbeach Marsh bordering upon Boston Deeps on the north,—which was declared by Order of Council to be an Area infected with foot-and-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the seventh day of October, one thousand eight hundred and eighty-three.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Areas (namely), -(1.) so much of the parishes of Oakham, Lordshold, and Oakham Deanshold with Barleythorpe, in the county of Rutland, as lies on the west side of the Midland Railway, and (2.) the whole of the parish of Braunston, in the county of Rutland, —which were declared by Orders of Council dated respectively the sixth and eighth days of September, one thousand eight hundred and eighty-three, to be Areas infected with foot-and-mouth disease, are hereby declared to be free from foot-andmouth disease, and those Areas shall, as from the commencement of this Order, ceuse to be Areas infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the seventh day of October, one thousand eight hundred and eighty-three.
