-shire,—is, except such portions thereof as are included in the Areas described in Article 2 of this Order, hereby declared to be free from foot-and-mouth disease, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. The following Areas (namely),-(1.) the whole of the parishes of Addlethorpe, Burgh-le-Marsh. Bratoft, Croft, Ingoldmells, Irby, Orby, Skegness, Thorpe, Winthorpe, and Wainfleet, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolnshire; (2.) the whole of the parishes of Brinkhill, and Driby, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolnshire; (3.) the whole of the parishes of Bolingbroke, Hagnaby, East Kirkby, West Keal, and Stickford, in the petty sessional division of Spilsby, in the Parts of Lindsey, Linds colnshire; (4.) the whole of the parishes of East Ville, and Sibsey, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolushire; (5.) the whole of the parishes of Spilsby, and Toynton, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolnshire; and (6.) the whole of the parishes of Great Steeping, and Little Steeping, in the petty sessional division of Spilsby, in the Parts of Lindsey, Lincolnshire,—shall continue to be and are hereby declared to be Areas infected with foot-and-mouth disease.

3. This Order shall take effect from and immediately after the twelfth day of October, one thousand eight hundred and eighty-three.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do hereby define the following part of the Port of London as a Foreign Animals Wharf:

All that space known as the Foreign Cattle Market belonging to the Corporation of London, situate on the Banks of the River Thames at Deptford, occupying an area of twenty-six acres

or thereabouts, formerly part of the Royal Dock Yard at Deptford, bounded, northward by a wall extending from the Victoria-road to the River Thames and separating such Market from the Royal Victualling Yard, eastward by the River Thames, southward by a wall extending from the River Thames to Dock-street, and separating such Market from Old King-street, Orchard-place, and Dock-street, south-eastward by a wall separating such Market from Dock-street and Princesstreet, and westward by a wall extending from Princes-street to the Victoria-road before-mentioned and separating such Market from lands and premises belonging to William John Evelyn, Esquire, together with the three Piers projecting therefrom into the River Thames; which space is edged pink on the plan of the Foreign Cattle Market deposited for the purposes of this Order at the Privy Council Office, a copy of which is deposited at the office of the Town Clerk of the City of London. THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area declared by Order of Council dated the thirty-first day of August, one thousand eight hundred and eighty-three, to be an Area infected with foot-and-mouth disease (namely),—the whole of the lands lying within the Pevensey, Willingdon, and Westham Levels, the whole of that portion of the parish of Hailsham lying within the Liberty of Pevensey, and all that part of the parish of Herstmonceux, including the whole of the Hobney's, which lies within the said Liberty of Pevensey, in the county of Sussex,—is, except such portion thereof as is included in the Area described in Article 2 of this Order, hereby declared to be free from foot-and-mouth disease, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. The following Area (namely),—so much of the county of Sussex as is comprised within the following boundary, that is to say, from the White Ditch by Broad Wall to Horseye Bridge, from Horseye Bridge by the highroad to Rickney, from Rickney by the highroad to Chilly, from Chilly by the highroad to Broadwater in Pevensey, thence by the Haven to Does Corner, thence by the Haven to Wartling Hill, thence by the boundary of the Pevensey Marsh to Herstmonceux, thence by the road to Newbridge, thence by the road known as the Marshfoot Wall to the boundary of the said Marsh, and thence by the boundary of the said Marsh to White Ditch aforesaid,—shall continue to be and is hereby declared to be an Area infected with foot-and-mouth disease.

3. This Order shall take effect from and immediately after the thirteenth day of October, one thousand eight hundred and eighty-three.
