THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the fifteenth day of October, one thousand eight hundred and eighty-three.

An Area comprising the whole of Claybury Park, in the parish of Chigwell, in the county of Essex.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—so much of the township of Winshill and of the township of Stapenhill in the county of Derby as is within the borough of Burton-upon-Trent,—which was declared by Order of Council dated the third day of September, one thousand eight hundred and eighty-three, to be an Area infected with footand-mouth disease, is hereby declared to be free from foot-and-mouth disease, and that Area shall, as from the commencement of this Order, cease to be an Area infected with foot-and-mouth disease.

2. This Order shall take effect from and immediately after the sixteenth day of October, one thousand eight hundred and eighty-three.

#### THE CONTAGIOUS DISEASES (ANIMALS) ACT, 1878.

#### (FOOT-AND-MOUTH DISEASE.)

THE following Areas are now Areas Infected with Foot-and-Mouth Disease under the abovementioned Act (except the lines of railway within those Areas as far as those lines are used or required for the transit of animals through those Areas, without untrucking):--

Anglesey.—(1.) In the parish of Holyhead, in the county of Anglesey, bounded on the south by the road leading from Towyn Penrhos towards Llanfawr, on the south-west by the road leading from the Llanfawr-road to Black Bridge where the same joins the Turkey Shore-road, on the north partly by the Turkey Shore-road and partly by the sea, and on the east by the sea.

(2.) In the parish of Holyhead, in the county of Anglesey, bounded on the north-east by the Shrewsbury and Holyhead turnpike-road, on the east and south-east by a road leading from the last-named road at the Gardener's Lodge, Penrhos, over the Railway and past Trego Cae glas and Treddaniel into the road next described, on the south-west by a road leading from Holyhead to Trearddwr, and on the north-west by a road leading from the last-mentioned road near the Alms Houses to the turnpike-road first-mentioned.

- Bedfordshire.--(1.) The parishes of Melchbourne, Yielden, and Dean, in the county of Bedford.
  - (2.) The parishes of Streatley, and Sundon, in the county of Bedford.
    (3.) The parishes of Pertenhall, and Keysoe,
  - in the county of Bedford.
  - (4.) The parishes of Poddington, Wymington, and Farndish, in the county of Bedford.
