by official information that the sanitary condition of Egypt, and all the ports situated beyond the Suez Canal is notably bettered, decrees :---

ART 1. The quarantine on ships arriving from ports and harbours on the Suez Canal, or beyond it, shall from this day be fixed at ten days whatever the length of the voyage, so long as they arrive without having had a case of sickness.

ART. 2. No change is made for these arrivals in the dispositions relative to the treatment of cargo, as laid down in the Ordinance, No. 9, of the 3rd of July last.

The Prefects of the Maritime Provinces are charged with the execution of this Ordinance.
