"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Barnabas situate in the parish of Hove aforesaid.

"Now therefore, with the consent of the Right Reverend Richard Bishop of the said diocese of Chichester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Hove which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Barnabas situate in the parish of Hove as aforesaid, and that the same should be named 'The District Chapelry of Saint Barnabas Hove.'

"And with the like consent of the said Richard Bishop of the said diocese of Chichester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Barnabas situate in the parish of Hove as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being : Provided always, that so long as the Reverend Thomas Peacey now vicar or incumbent of the vicarage of the said parish of Hove shall continue to be such vicar or incumbent all the fees which may be received in respect of such publication solemnization or performance at the said church of Saint Barnabas situate as aforesaid shall be paid over by the minister thereof to the said Thomas Peacey, and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order with respect thereto as to Your Majesty, in your Royal wisdom, shall seem meet.

. " The SCHEDULE to which the foregoing

Representation has reference.

"The District Chapelry of Saint Barnabas Hove being :--

"All that part of the parish of Hove in the county of Sussex and in the diocese of Chichester, which is bounded on the south and on the east by an imaginary line commencing at the point where the boundary dividing the said parish of Hove from the parish of Aldrington in the county and diocese aforesaid crosses the middle of Clarendon Villas-road, and extending thence eastward along the middle of the said road for a distance of $13\frac{1}{4}$ chains or thereabouts to its junction with Sackvilleroad and extending thence northward along the middle of the last-named road for a distance of 6 chains or thereabouts to its junction with Shirley-street, and extending thence eastward along the middle of the last-named street for a distance of 20 chains or thereabouts to its junction with the road which passes in front of the houses called or known as Goldstone-villas and extending thence northward along the middle of the last described road for a distance of 12 chains or thereabouts to the open space or yard on the | southern side of the West Brighton Station of the West Branch Line of the London Brighton and South Coast Railway and continuing thence still northward and in a direct line for a distance of $3\frac{1}{2}$ chains or thereabouts across the said open space or yard and across the said West Brighton Station and across the open space or yard on the northern side of the same station to a point in the middle of the southern end of West Brighton-road and continuing thence still northward along the middle of the last-named road for a distance of $16\frac{1}{2}$ chains or thereabouts to the boundary at the present northern end of the same road, which boundary divides, the said parish of Hove from the parish of Preston in the county and diocese aforesaid.

"All which said hereinbefore described part of the parish of Hove aforesaid is bounded upon the remaining sides, other than upon the south and east as aforesaid, that is to say upon the north and upon the west as follows upon the north partly by the said parish of Preston, and partly by the parish of West Blatchington in the county and diocese aforesaid, and upon the west by the parish of Aldrington aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester. *C. WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty, chapter thirtyseven, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the eighth day of November, in the year one thousand eight hundred and eighty-three in the words and figures following, that is to say :--

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and of the Act of the ninetcenth and twentieth years of Your Majesty chapter one hundred and four have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken out of the parish of Swanscombe in the county of Kent and in the diocese of Rochester.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Swanscombe which is hereinafter mentioned and described should be constituted a separate district in manner hereinafter recommended and proposed.

"And whereas there is not at present within the limits of the said proposed district any consecrated
