Port Said—Intended Alteration in Lights.

INFORMATION has been received from the Egyptian Government, that on 1st March, 1884, the following alteration will be made in the lights at Port Said, northern entrance to the Suez Canal:-

1. The light-vessel, now moored 12 cables seaward of the outer extreme of the western breakwater which is awash, will be withdrawn; and in lieu thereof, a light will be exhibited from a beacon erected 110 yards seaward of the outer extreme of that portion which is awash, and in the same line of direction.

The light will be a fixed red light.

2. The outer extreme of that portion of the western breakwater which is awash will be marked by a buoy carrying a fixed white light.

This buoy will be moored in the line of direction of that portion of the breakwater which is awash, about 100 yards within the beacon with red light.

Note.—The two above-mentioned lights will be lighted by stored gas, Pintsch system.
