WHEREAS by Order in Council, made in pursuance of the Merchant Shipping Act Amendment Act, 1862, and dated the fourteenth day of August one thousand eight hundred and seventy-nine, Her Majesty, on the joint recom-mendation of the Admiralty and the Board of Trade, was pleased to direct that, on and after the first day of September one thousand eight hun-dred and eighty, the Regulations for preventing collisions at sea, contained in an Order in Council dated the ninth day of January one thousand eight hundred and sixty-three, and the additions by an Order in Council dated the thirtieth day of June one thousand eight hundred and sixty-eight, made thereto, should be annulled, and that there should be substituted therefor the new Regulations contained in the First Schedule to the said first-named Order in Council, and that the same should, from and after the first day of September one thousand eight hundred and eighty, apply to ships of the countries mentioned in the said Second Schedule thereto, whether within British jurisdiction or not.

And whereas, by Order in Council, dated the twenty-third day of August one thousand eight hundred and eighty-three, Her Majesty was pleased to direct that the operation of the Article numbered 10 of the New Regulations contained in the First Schedule of the said Order in Council of the fourteenth day of August one thousand eight hundred and seventy-nine should be suspended until the first day of March one thousand eight hundred and eighty-four, and that in lieu thereof, and in substitution therefor, the Article numbered 9 of the Regulations appended to the said Order in Council of the ninth day of January one thousand eight hundred and sixty-three should continue and remain in force until the said first day of March one thousand eight hundred and eighty-four.
