Lancashire. THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of the following Quarantine Notice issued by the Austro-Hungarian Government:-

"From the Maritime Department to all the Imperial and Royal Harbour and Maritime Health Officers and functionaries under its administration:

"By order of the Imperial and Royal Ministry of Commerce, in concert with the Royal Hungarian Ministry of Commerce, transmitted by telegram of to-day's date, No. 4494; the Maritime Department decrees:

"The quarantine of observation for vessels showing clean bills of health, and arriving in an entirely normal condition, from Egypt, is reduced to five days; that for vessels arriving from the Turkish ports of the Red Sea and from the East Indies, provided they have not touched Egypt on their passage through the Suez Canal, is reduced to three days.

"The twenty-four hours' quarantine, ordered by the Departmental Circular of October 11, 1883, No. 9469, respecting arrivals from the other Turkish, Asiatic, and African ports, is abolished, and the vessels in question shall be subject to medical inspection before they are admitted to pratique.

" For vessels coming from the Turkish ports of the Red Sea, or from Egyptian or East Indian ports, via the Suez Canal, and which do not fulfil the requirements of a clean health bill and arrival in quite normal conditions, the ten days' quaranține is retained.

"The present regulation applies to vessels arriving from the places above specified, which are undergoing quarantine in Austrian ports.
