#### TENDERS FOR LOANS ON TREASURY BILLS.

1. THE Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England, on Monday, the 3rd proximo, at one o'clock, for Treasury Bills to be issued under the Act 40 Vic., cap. 2, to the amount of £1,915,000.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000. They will be dated the 7th day of March, 1884, and will be payable at three or six months after date (at the option of the persons tendering), viz.:—on the 7th June or 7th September next, respectively.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for; and the tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 4th proximo, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock, on Friday, the 7th proximo.

6. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

#### EXCHEQUER BILLS.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice to the holders of Exchequer Bills issued under the authority of the Act 29 Vic., c. 25, and dated the 11th March, 1882, and 11th March, 1883, that the Interest thereon for the half-year ending on the 11th March, 1884, will be payable at the Bank of England, on and after the 11th March next; and that the Interest of such Exchequer Bills for the following half-year, to 11th September, 1884, will be at the rate of three per centum per annum.

All holders of Exchequer Bills dated the 11th March, 1882, and 11th March, 1883, who intend to demand payment of the principal sums therein contained at the expiration of the second and first years respectively of their currency, must leave the said Bills at the Bank of England for examination not later than the 8th March next, between the hours of ten and two; and payment of the said principal sums will be made at the Bank on and after the 11th day of March next.
