map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Thomas-in-the-Moors situate within the limits of such new parish as aforesaid, and that the same should be named 'The District Chapelry of Saint Thomas-in-the-Moors Balsall Heath.

"And with the like consent of the said Henry, Bishop of the said diocese of Worcester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Thomas-inthe-Moors situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in

Your Royal wisdom, shall seem meet.

" The SCHEDULE.

"The District Chapelry of Saint Thomas-inthe Moors, Balsall Heath, being :-

"All that part of the new parish (sometime district chapelry) of Balsall Heath in the county of Worcester, and in the diocese of Worcester which is bounded on the north and on the east by an imaginary line commencing upon the boundary which divides the said new parish from the parish of Edgbaston in the county of Warwick and in the diocese of Worcester aforesaid at the centre of the bridge which carries Belgrave-street over the River Rea, and extending thence south-eastward along the middle of the said street for a distance of twelve chains or thereabouts to its junction with Seymour-street, and extending thence southwestward along the middle of the last-named street for a distance of seven chains or thereabouts to its junction with Sherborne-road and extending thence north-westward along the middle of the last-named road for a distance of three chains or thereabouts to its junction with Longbridge-road, and extending thence southward along the middle of the last-named road for a distance of six and a half chains or thereabouts to its junction with Balsall Heath-road and extending thence south-eastward along the middle of the last-named road for a distance of two and a half chains or thereabouts to its junction with Mary-street and extending thence southward along the middle of the last-named street for a distance of twenty-two chains or thereabouts to its junction with Edwardes-street and with Upper Marystreet, and continuing thence still southward across the said Edwardes-street, and then southward and south-eastward along the middle of Upper Marystreet aforesaid for a distance of twenty chains or thereabouts to the boundary at the junction of the last-named street with George-street and with Edgbaston-road which boundary divides the said new parish of Balsall Heath from the new parish of Saint Anne Moseley, in the said county of Worcester and in the diocese of Worcester aforesaid.

"All which said hereinbefore described part of the new parish of Balsall Heath aforesaid is bounded upon the remaining sides other than

upon the north and east as aforesaid, that is to say upon the south and upon the west as follows, upon the south by the new parish of Saint Anne, Moseley aforesaid, and upon the west by the parish of Edgbaston aforesaid.

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the. London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixtcenth and seventeenth years of Her Majesty, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty fourth day of January, in the year one thousand eight hundred and eighty-four, in the words and figures

following, that is to say:

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixteenth and seventeenth years of Your Majesty chapter fifty and of the Act of the twenty-third and twenty fourth years of Your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to each of two benefices, namely, the church and cure of Clynnog (being a vicarage) and the church and cure of Llanwnda (being a vicarage) with Llanfaglen (being a chapelry in the parish of Llanwnda) each of which said two benefices is in the county of Carnarvon and in the diocese of Bangor, by way of exchange for the ownership of the advowson or perpetual right of patronage of and presentation to each of the two other benefices namely, the church and cure of Bodedern (being a vicarage) and the church and cure of Llandrygarn (being a vicarage) with Bodwrog (being a chapelry in the parish of Llandrygarn) each of which said two lastly-named benefices is in the county of Anglesey and in the said diocese of Bangor.

"Whereas the advowson or perpetual right of . patronage of and presentation to each of the said two benefices of Clynnog and Llanwnda with Llanfaglen is vested in the Bishop of the said

diocese of Bangor for the time being.

"And whereas the advowson or perpetual right of patronage of and presentation to each of the said two benefices of Bodedern and of Llandrygarn with Bodwrog is vested in the Principal Fellows and Scholars of Jesus College in the University of Oxford, and their successors.

"And whereas the Right Reverend James Colquboun, now Bishop of the said diocese of Bangor and the Reverend Hugo Daniel Harper Doctor in Divinity now Principal of Jesus College aforesaid, acting on behalf of the Principal Fellows
