bearing date the thirty-first day of January, in the | new parish of Christ Church Blackburn shall be year one thousand eight hundred and eighty-four, in the words following, that is to say:

"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Christ Church Blackburn in the county of Lancaster and in the diocese of Manchester and of the new parish of All Saints Nova Scotia Blackburn in the same county and

"Whereas by the authority of an Order of Your Majesty in Council bearing date the twenty-sixth day of October in the year one thousand eight hundred and sixty and published in the London Gazette upon the thirtieth day of the same month a portion of the parish of Saint Mary Blackburn in the county and diocese aforesaid was assigned as a district chapelry to the consecrated church called Christ Church situate within the limits of the said parish of Saint Mary Blackburn and the same district chapelry was called 'The District Chapelry of Christ Church Blackburn.

"And whereas by the authority of another Order of Your Majesty in Council bearing date the fifteenth day of October in the year one thousand eight hundred and seventy-two and published in the London Gazette upon the eighteenth day of the same month a part of the said parish of Saint Mary Blackburn was assigned as a district chapelry to the consecrated church of All Saints situate at Nova Scotia in the same parish and the same district chapelry was called The District Chapelry of All Saints Nova Scotia Blackburn.'

"And whereas the said district chapelry of Christ Church Blackburn and the said district chapelry of All Saints Nova Scotia Blackburn have under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four each now become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-

" And whereas it has been represented to us and it appears to us to be expedient that the boundaries of both the said new parishes should be altered in the manner hereinafter mentioned.

" Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of All Saints Nova Scotia Blackburn shall be extended so that they shall include all that portion of the said new parish of Christ Church Blackburn which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink and that from and after the day of the same date and without any assurance in law other than such duly gazetted Order the said portion of the said

dissevered from such new parish and shall be included within and shall become and be and form part of the said new parish of All Saints, Nova Scotia Blackburn.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the hereinbefore-mentioned Acts or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the new parish of Christ Church Blackburn in the county of Lancaster and in the diocese of Manchester and to be annexed to the new parish of All Saints-Nova Scotia, Blackburn in the same county and diocese being :-

"All that portion of the said new parish of Christ Church Blackburn which is bounded upon the north-east upon the south-east and upon the south-west by an imaginary line commencing upon the boundary which divides the said new parish of All Saints Nova Scotia Blackburn from the new parish of Christ Church Blackburn aforesaid at a point on the southern side of the Canal Bridge Nova Scotia which carries Bolton-road over the Leeds and Liverpool Canal and extending thence southward for a distance of fifty-eight yards or thereabouts along the eastern side of the said Bolton-road across the western end of Infirmarystreet and along the eastern side of Infirmaryroad to the point where the last-named road is joined by the Back-road which passes in rear of the houses situate on the south-western side of Infirmary-street aforesaid and extending thence that is from Infirmary-road aforesaid southeastward along the south-western side of the said Back-road for a distance of one hundred yards or thereabouts thereby passing in part along the wall or fence forming the north-eastern boundary of the land which by a deed dated the fourth day of December one thousand eight hundred and seventynine has been conveyed to the Ecclesiastical Commissioners for England as and for a site for a vicarage house for the said new parish of All Saints Nova Scotia Blackburn to the point at the south-eastern end of the said Back-road where the said wall or fence joins the wall or fence forming the south-eastern boundary of the site of the vicarage house aforesaid and extending thence first southward and then south-westward along the last-described wall or fence for a distance of sixty-one yards or thereabouts (thereby passing in the last-named direction along the north-western side of the grounds attached to the vicarage house of the new parish of Christ Church Blackburn aforesaid) to the south-western end of the said last-described wall or fence on the north-eastern side of Infirmary-road aforesaid and continuing thence still south-westward and in a direct line across the last-named road to a point on its south-western side and extending thencegenerally north-westward along the south-western side of the said Infirmary-road for a distance of one hundred and twenty-five yards or thereabouts to its junction with Bolton-road aforesaid and continuing thence still north-westward and in a direct line to the boundary in the middle of the lastnamed road which boundary divides the said new parish of Christ Church Blackburn from the new parish of All Saints Nova Scotia Blackburn afore-
