And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty Kirg George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the seventh day of February, in the year one thousand eight hundred and eighty-four, in the words following; that is to say:—

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint John the Baptist, situate within the limits of the parish of Woking, in the county of Surrey, and in the diocese of Winchester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint John the Baptist, situate within the limits of the parish of Woking as aforesaid.

"Now therefore, with the consent of the Right Reverend Edward Harold, Bishop of the said diocese of Winchester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Woking, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint John the Baptist, situate within the limits of such parish as aforesaid, and that the same should be

named 'The District Chapelry of Saint John the

Baptist, Woking.'

And with the like consent of the said Edward Harold, Bishop of the said diocese of Wincliester (testified as aforesaid), we, the said Ecclesinstical Commissioners, further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint John the Baptist, situate as afore-aid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be practiously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in

Your Royal wisdom, shall seem meet.
