THE Board of Trade have received from the Secretary of State for Foreign Affairs a Despatch from Her Majesty's Consul at San José. Costa Rica, on the subject of the regulations in force at Port Limon respecting consular invoices. The following extract from the Despatch contains the purport of the regulations referred to:—

"It is obligatory on every shipper of merchandise for the Republic of Costa Rica to send consular invoices (in triplicate) for each shipment, expressing therein for account of whom, marks, numbers, gross weight, value, and detailed contents of each package. Of these invoices, the Consul for Costa Rica will transmit one copy direct to the Minister of Finance, and one to the Manager of the Goods Depôt at the ports of destination, and the third copy should be sent by the shipper to the person for whom the goods are intended.

"In the absence of a Costa Rican Consular Officer to certify invoices, it can be done by the Consular Officer of a friendly Power; or, in default of this, by two merchants in the place, provided their signatures are authenticated by the local authority."

It is intimated by the Consul that great inconvenience and delay will be caused, and heavy fines imposed on native as well as foreign merchants in Costa Rica, in the event of shippers not complying with these regulations.
