##### WILSTONE FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Justices of the Peace, in and for the Petty Sessional Division of Dacorum, in the county of Hertford, sitting as a Court of Summary Jurisdiction at Berkhamsted Saint Peter, that Fairs have been annually held at or about Old Michaelmas, in the hamlet of Wilstone, within the said Petty Sessional Division of the said county, and that it would be for the convenience and advantage of the public that the said Fairs should be abolished:
