WHEREAS by an Act passed in the Session of Parliament held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the laws concerning the burial of the dead in England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the

aforesaid, may seem fit:

And whereas Orders in Council have been made directing the discontinuance of burials in the churchyards hereinafter mentioned from the time specified in such Orders; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing

said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as

burials in the said churchyards be postponed:

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards be postponed as follows, viz.:

In the churchyard of Ripton-Abbotts, in the county of Huntingdon, to the thirtieth day of April, one thousand eight hundred and eighty-four.

In the churchyard of Edmonton, Middlesex, to the first day of May, one thousand eight hundred and eighty-four.

In the churchyard of Coningsby, in the county of Lincoln, to the first day of July, one thousand eight hundred and eighty-four.

In the churchyard of St. John's, Moulsham, in the parish of Chelmsford, in the county of Essex, to the thirty-first day of July, one thousand eight hundred and eighty-four.

In the parish churchyard of Hornsea, in the county of York, to the thirtieth day of June, one thousand eight hundred and eighty-four.
