

sioners for England deem it expedient that a particular district, to comprise a portion of the said parish of Sutton and a portion of the new parish of Benhilton, in the said county of Surrey, and in the diocese of Rochester aforesaid, and also a portion of the parish of Carshalton, in the same county and diocese, should be assigned to the said church of Saint Barnabas, Sutton New Town, and also that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church.

Now know ye, that the said Ecclesiastical Commissioners for England, in exercise and execution of the powers or authorities for this purpose contained in the several Acts of Parliament called "The Church Building Acts" as aforesaid, or in some of them, and particularly in the Act of the first and second years of His late Majesty King William the Fourth, chapter thirty-eight, in the said Act of the fourteenth and fifteenth years of Her said Majesty, chapter ninety-seven, and also in the said Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling them in this behalf, do hereby, with the consent of the said Anthony Wilson, Bishop of the said diocese of Rochester (testified by his being a party to and executing these presents), assign to the said church of Saint Barnabas, Sutton New Town, as a particular district, all those portions of the said parish of Sutton, of the said new parish of Benhilton, and of the said parish of Carshalton, which are described in the schedule hereunder written, and are delineated and set forth upon the map or plan hereunto appended, and do direct that the same district shall be called "The Particular District of Saint Barnabas, Sutton New Town."

And the said Ecclesiastical Commissioners for England, with the like consent of the said Anthony Wilson, Bishop of the said diocese of Rochester (testified as aforesaid), in further exercise and execution of the powers or authorities contained in the said Acts of Parliament called "The Church Building Acts," or in some of them, and particularly in the said Act of the first and second years of His late Majesty King William the Fourth, chapter thirty-eight, in the Act of the third and fourth years of Her present Majesty, chapter sixty, in the Act of the seventh and eighth years of Her said Majesty, chapter fifty-six (such two lastly-mentioned Acts being also two of "The Church Building Acts" before named), in the said Act of the fourteenth and fifteenth years of Her said Majesty, chapter ninety-seven, and in the said Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling them in this behalf, do hereby determine and declare that banns of matrimony shall be published, and that marriages, baptisms, churchings, and burials shall be solemnized or performed at the church of the said particular district of Saint Barnabas, Sutton New Town, and do hereby order and direct that all the fees, dues, offerings, or other emoluments to be received in respect of such publication of banns of matrimony, and of such solemnization or performance of marriages, baptisms, churchings, and burials at the same church shall, from and after the next avoidance of the three cures aforesaid, namely, the parish of Sutton, the new parish of Benhilton, and the parish of Carshalton, as such avoidances shall respectively occur, belong to the Incumbent for the time being of the said particular district of Saint Barnabas, Sutton New Town: Provided always, that

nothing herein contained shall be construed as expressing any intention on the part of the said Ecclesiastical Commissioners for England to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

In witness whereof, the said Ecclesiastical Commissioners for England, have hereunto affixed their common seal, and the said Anthony Wilson, Bishop of the said diocese of Rochester, has hereunto set his hand and affixed his episcopal seal, this third day of April, in the year one thousand eight hundred and eighty-four.

The SCHEDULE.

The Particular District of Saint Barnabas, Sutton New Town, being:—

All those several contiguous portions of the parish of Sutton; of the new parish of Benhilton, and of the parish of Carshalton, all in the county of Surrey, and in the diocese of Rochester, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said parish of Sutton from the new parish of Benhilton aforesaid, at the point where the said several roads, called or known respectively as Benhill-street, Manor-lane, Jenny Lind-road, Lower-road, and Thicket-road all meet, and extending thence, generally northward, along the middle of the last-named road for a distance of twenty-two chains, or thereabouts, to its junction with Oakhill-road, and extending thence eastward along the middle of the last-named road for a distance of nine chains, or thereabouts, to its junction with Benhill-road and with Erskine-road, and continuing thence still eastward along the middle of the last-named road for a distance of three and a half chains, or thereabouts, to its junction with Pellatt-road, and extending thence south-eastward and in a direct line for a distance of forty-three chains, or thereabouts (thereby crossing the boundary which divides the said new parish of Benhilton from the parish of Carshalton aforesaid), and passing to the south-west of the dwelling house at Westmead Farm, to a point at the centre of the bridge which carries the Peckham and Sutton Line of the London, Brighton, and South Coast Railway over Dark-lane, and extending thence first south-westward and then westward along the middle of the said line of railway for a distance of sixty-six chains, or thereabouts (thereby crossing the boundary which divides the said parish of Carshalton from the parish of Sutton aforesaid), to the centre of the bridge which carries the same line of railway over Goodenough's-lane, and extending thence northward along the middle of the last-named lane for a distance of nine and a half chains, or thereabouts, to its junction with Carshalton-road, and extending thence northward and in a direct line for a distance of eight and a half chains, or thereabouts, across the premises known as the Sutton District Waterworks to the point where Greyhound-road is joined by Myrtle-road, and extending thence still northward along the middle of the last-named road for a distance of ten and a half chains, or thereabouts, to its junction with Manor-lane aforesaid, and extending thence eastward along the middle of the last-named lane for a distance of five chains, or thereabouts, to the first described point upon the boundary which divides the said parish of Sutton
