WE, the undersigned, being two of the Lords Commissioners of Her Majesty's Treasury, by virtue of the fourteenth section of the Courts of Justice Salaries and Funds Act, 1869, and all other powers enabling us in that behalf, and with the concurrence of the Lord Chancellor, do hereby order and determine that, from and after the date of this Order, the conditions on which any Principal Secretary to the Lord Chancellor hereafter appointed shall hold office, shall be as follows, that is to say: the Principal Secretary shall be a Barrister of Law of not less than seven years' standing, appointed by the Lord Chancellor, and shall hold his office subject to removal by the Lord Chancellor by order for some sufficient reason to be stated in such order, at such yearly salary, not exceeding $\pounds 1,500$, as the Lord Chancellor, with the concurrence of the Treasury, shall from time to time direct, and shall for the purposes of salary and pension be deemed to be a permanent Civil Servant of the State.
