THE Board of Trade have received through the Secretary of State for Foreign Affairs the following Telegram from Her Majesty's Consul at Bilbao:—

"25th June, 1884.—In consequence of the appearance of cholera at Toulon, vessels coming to Bilbao from French ports will have to perform full quarantine at Santander. Also arrivals from Burmah, Siam, Anam, and Malacca; if precautions taken at Gibraltar, three days' observation, if not, full quarantine."
