And to all others whom it may concern.

WHEREAS. by certain Orders of the Poor --Law Commissioners, the Poor Law Board, and the Local Government Board, addressed to the said Boards of Management, Regulations have been prescribed with respect to the appointment of persons to hold certain offices at the Schools of such . Districts, including the offices of Porter and Nurse, -or one of those offices;

And whereas it is expedient to amend the afore--said Regulations as hereinafter mentioned :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows :-

Every person appointed to the office of Porter or Nurse by any of the said Boards of Management from and after the first day of January, one thousand eight hundred and eighty-five, may be dismissed by the Board of Management without Our consent; but every such dismissal shall be reported to Us together with the circumstances relating thereto.
