1884. ORDINANCE OF MARITIME HEALTH No. 42.

Cholera having completely ceased in Naples and in every port of the kingdom, the Minister of the Interior decrees :—

The quarantine of observation now in force in the Islands of Sicily, Sardinia, and those adjacent, against ships coming from the Italian continent and from the other islands of the kingdom, is from this day reduced to a period of five days, if they have no sickness on board.

The same treatment shall be applied to ships which are at this moment undergoing quarantine.
