WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the vicarage of Saint Stephen, South Lambeth, in the county of Surrey, and in the diocese of Rochester, one yearly sum or stipend of sixty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the twenty-first day of December, in the year one thousand eight hundred and eighty-four, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said vicarage of Saint Stephen, South Lambeth, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year of a certificate under the hand of the Bishop of the said diocese of Rochester, that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Saint Stephen, South Lambeth aforesaid, during the quarter of the year then ended, and is in receipt of a salary after a rate of not less than one hundred and twenty pounds per annum: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said vicarage and parish of Saint Stephen, South Lambeth.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of one thousand pounds sterling, which has been paid to us in favour of the rectory of Christ Church, Barlow Moor-road, Didsbury, in the county of Lancaster, and in the diocese of Manchester, and in consideration also of a further benefaction, consisting of a piece or parcel of land, comprising one thousand and six hundred square yards, or thereabouts, which has been permanently secured to the same rectory, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant to the Incumbent of the said rectory

of Christ Church, Barlow Moor-road, Didsbury, and to his successors, Incumbents thereof, to meet the aforesaid benefactions, one yearly sum or stipend of thirty-three pounds six shillings and eight pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: And we do also, in further consideration of the above-mentioned benefactions, hereby grant and appropriate out of our said common fund to the said rectory of Christ Church, Barlow Moor-road, Didsbury, one capital sum of five hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said rectory, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said rectory of Christ Church, Barlow Moor-road, Didsbury; Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend of thirty-three pounds six shillings and eight pence, or any part thereof, shall be annexed by us to the said rectory in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, in consideration of certain benefactions, consisting (first) of a sum of two hundred and fifty pounds sterling, which has been paid to us in favour of the rectory of All Souls, Ancoats, in the county of Lancaster, and in the diocese of Manchester, and (secondly) of certain land, comprising three hundred and twenty-three and one-third square yards, or thereabouts, and the buildings thereon, which have been secured to the same rectory, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said rectory of All Souls, Ancoats, to meet the aforesaid benefactions, one capital sum of seven hundred and fifty pounds sterling, to be applicable towards defraying the cost of enlarging and otherwise improving the buildings hereinbefore mentioned, with a view to making them suitable for a parsonage or house of residence for the said rectory, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of three pounds per centum per annum, and such interest to be paid to the Incumbent for the time being of the said rectory of All Souls, Ancoats.
