NOTICE is hereby given, that His Royal Highness The Prince of Wales will, by command of The Queen, hold Levees at St. James's Palace, on behalf of Her Majesty, on Monday, the 2nd of March, and on Saturday, the 14th of March next, at two o'clock.

It is The Queen's pleasure that Presentations to His Royal Highness at the Levees shall be considered as equivalent to Presentations to Her Majesty.

REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEES TO BE HELD BY HIS ROYAL HIGHNESS THE PRINCE OF WALES, ON BEHALF OF HER MAJESTY, AT ST. JAMES'S PALACE.

By Her Majesty's Command,

The Noblemen and Gentlemen who propose to attend Her Majesty's Levees, at St. James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve o'clock*, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command that no presentations shall be made at Levees, except in accordance with the above regulations.

It is particularly requested, that in every case he names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.

The New Forest (Swine-Fever) No. 2 Order of 1884 is hereby revoked: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before this Order takes effect, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order hereby revoked before this Order takes effect.

2. This Order shall take effect from and immediately after the eighteenth day of February, one thousand eight hundred and eighty-five.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul at Fiume enclosing the following translation of a notice respecting quarantine issued by the Royal Hungarian Maritime Government, viz. :—

CIRCULAR from the Royal Hungarian Maritime Government to all Royal Hungarian Port Offices and their agencies.

As per order of the Royal Hungarian Ministry of Commerce, with despatch dated 3rd February, No. 5002, the Royal Hungarian Maritime Government, in concert with the Imperial Royal Maritime Government of Trieste, orders as follows :—

The sanitary observation of five days ordered by the Circular dated 2nd May, 1884, No. 1964, is hereby reduced to twenty-four hours for all arrivals from East Indies, if no case of infection occurred during the passage and everything on board be in normal conditions, the medical examination for these arrivals, however, will be maintained.

The present order is applicable also to vessels arrived from East Indies now undergoing the prescribed quarantine of five days.

(No. 19.)—NORTH SEA—COAST OF JUTLAND.—
 LIIMFIORD ENTRANCE.

(1.) *Rön Channel Light-Vessel—Intended Alteration in Character of Light.*

THE Danish Government has given notice, that the following alteration will be made in the character of the light exhibited from Rön (Thybo Rön) Channel Light-vessel, Liimfiord Entrance, when the vessel is replaced at her station in the month of March, 1885 :—

The light will be a fixed red light, elevated 31 feet above the sea, and should be visible in clear weather from a distance of six miles.

The illuminating apparatus will be dioptric, or by lenses, of the sixth order.

NOTE.—Ice permitting, this light-vessel will be kept in position from 20th March to 15th November.

BALTIC ENTRANCE—GREAT BELT.—LANGELAND
 —SOUTH-EAST COAST.

(2.) *Fixed Light at Kjeldsnor.*

Also, that on 20th January, 1885, a light would be exhibited from an iron pile lighthouse erected on the low sandy beach seaward of Kjeldsnor, south-east coast of Langeland :—

The light is a fixed white light, visible between the bearings of N. 79½° E., through west, and S. 53½° W.; it is elevated 50 feet above the sea, and should be seen in clear weather from a distance of nine miles.

The illuminating apparatus is dioptric, or by lenses, of the sixth order.

(3.) *Intended Fog-Signal at Tranekjær Lighthouse.*

(No. 20.)—MEDITERRANEAN—SARDINIA—SOUTH COAST.

(1.) *Cagliari—Harbour Works in Progress.*

THE Italian Government has given notice, that the construction of a breakwater eastward of the dock at Cagliari has been commenced, and that a vessel, painted red, is moored at its extremity; during the night a fixed red light is shown from this vessel.

Several buoys, painted red, have been placed to mark the breakwater works in progress; vessels should avoid these buoys.

The mooring buoy at the entrance to the dock has been removed.

NOTE.—A buoy, surmounted by a flag, has been placed at the southern extreme (previously marked by a pole) of Scaffa Shoal, Cagliari Bay.

ADRIATIC—EAST COAST.

(2.) *Cittanuova Harbour Light—Sector of Red Light.*

With reference to Notice to Mariners, No. 374 (1), of 31st December, 1883, on the exhibition of a fixed white light on the Mole Head at Cittanuova, south side of Port Cittanuova :—

The Austro-Hungarian Government has given further notice, that a sector of red light is now shown from the Mole Head between the bearings of N.E. by E. and S.E. by S., covering the space between the town and the breakwater extending from the mole.

NOTE.—Vessels should not steer towards the mole until the white light comes in sight, which leads clear of the breakwater.

(3.) *Port Tolero—Discontinuance of Bat Point Light.*

Also, that on 31st December, 1884, the light on Bat Point, Port Tolero (the old mouth of Tarenta River), would be discontinued.

CHILE.

(1.) *Lota Bay—Revolving Light on Lota Point.*

WITH reference to Notice to Mariners, No. 151 (1), of 9th June, 1883, on the intended exhibition of a light from a lighthouse, then in course of construction, on Lota (Lutrin) Point, north side of entrance to Lota Bay :—

The Chilean Government has given notice, that on 1st December, 1884, the light was exhibited :—

The light is a revolving white light, attaining its greatest brilliancy every fifteen seconds, elevated 160 feet above high water, and should be visible in clear weather from a distance of 18 miles. The light is obscured to the northward by the heights of Chambique, bearing N. by W. from the lighthouse.

The illuminating apparatus is dioptric, or by lenses, of the fourth order.

The lighthouse, 4½ feet high, constructed of iron and cylindrical in shape, is painted white.

Position, lat. 37° 5' 20" S., long. 73° 11' 15" W.

NORTH AMERICA—WEST COAST.—CALIFORNIA.

(2.) *Montara Point Fog Signal—Alteration in Character.*

The United States Government has given notice, that on 1st March, 1885, the following alteration will be made in the character of the fog signal at Montara Point, southward of San Francisco Bay :—

During thick or foggy weather, a blast will be sounded of five seconds' duration, followed by an interval of twenty-five seconds.

PORT PHILLIP—SOUTH CHANNEL.

(1.) *Eastern Lighthouse—Alterations in Upper Light, Discontinuance of Lower Light.*

WITH reference to Notices to Mariners, No. 97, of 21st July, 1874, on the establishment of Eastern light, immediately under Arthur's Seat, South Channel, Port Phillip; and No. 15, of 31st January, 1878, on the exhibition of an auxiliary white light, placed 40 feet below the above mentioned light :—

The Government of Victoria has given further notice, that on 1st January, 1885, a new and more powerful light would be exhibited in lieu of the previous upper light; and that the lower light would be discontinued :—

The new Eastern Light shows as heretofore fixed red between the bearings of S. by W. ½ W. and S. E. ¼ E., and fixed white between S. E. ¼ E. and E. by N. ½ N.; it is elevated 100 feet above high water, and should be visible in clear weather from a distance of about 13 miles.

The illuminating apparatus is dioptric, or by lenses, of the third order.

The lighthouse, constructed of iron, is painted white.

AUSTRALIA—NORTH COAST.—CLARENCE STRAIT.

(2.) *Vernon Islands—Buoy marking Shoal Ground.*

(1.) *Liverpool Bay—Intended Adoption of the Uniform System of Buoyage.*

THE Mersey Docks and Harbour Board has given notice, that in the early part of the summer of 1885, it is intended that the Uniform System of Buoyage recommended by the Report of the Buoyage Conference of 1st May, 1883, under the presidency of H.R.H. the Duke of Edinburgh, shall be adopted in buoying the sea channels of the Mersey in Liverpool,

The principal arrangements of the Uniform System as applicable to Liverpool Bay are as follows :—

Channel Buoys.

The term "starboard hand" denotes that side of a channel which, when inward bound, is on the right hand of the mariner. The term "port hand" denotes the left hand of the mariner in the same circumstances.

The shape and colours of the buoys to be used are :—

Starboard hand buoys, conical, red.

Port hand buoys, can, black.

Spits of banks intervening between two channels or middle grounds will be marked by spherical buoys, painted with white rings on a dark ground.

Beacon Buoys.

When a buoy is surmounted by a beacon, a staff and globe indicates a starboard hand buoy; a staff and cage a port hand buoy; a staff and

diamond or triangle a buoy intervening between two channels.

Every buoy bears the initial letter of the channel to which it belongs, and in some cases additional letters, also a number indicative of its situation counting from seaward—thus, Q 1 is the outer buoy of Queen Channel; C 5 is the fifth buoy inward of Crosby Channel; HE Fy., Hilbre Fairway Buoy, &c.

The shapes above mentioned as conical and can denote those hitherto known as nun and can respectively. Under the Uniform System, these shapes will each take the opposite side to that which they now occupy; the colours remaining the same on each side as at present—thus conical buoys will be red on the starboard hand, can buoys black on the port hand.

Special Buoys.

Pillar buoys, bell buoys, and other shapes may be used to mark special points in a channel, and as fairway buoys in the approach to a channel, or as outlying buoys outside the banks.

Further notice will be given, stating the dates to be fixed for changing the buoys successively in each of the sea channels, together with any additions to, or changes to be made in, existing stations.

BYE-LAWS and Regulations made by the Wigan Tramways Company Limited, under the powers conferred on the Company by "The Tramways Act, 1870."

1. The Bye-laws and Regulations hereinafter set forth shall extend and apply to all carriages of the Company, and to all places with respect to which the Company have power to make Bye-laws or Regulations.

2. Every passenger shall enter or depart from a carriage by the hindermost or conductor's platform, and not otherwise.

3. No passenger shall smoke inside any carriage.

4. No passenger or other person shall, while travelling in or upon any carriage, play or perform upon any musical instrument.

5. A person in a state of intoxication shall not be allowed to enter or mount upon any carriage, and if found in or upon any carriage shall be immediately removed by or under the direction of the conductor.

6. No person shall swear or use obscene or offensive language whilst in or upon any carriage, or commit any nuisance in or upon or against any carriage, or wilfully interfere with the comfort of any passenger.

7. No person shall wilfully cut, tear, soil, or damage the cushions or the linings, or remove or deface any number plate, printed or other notice, in or on the carriage, or break or scratch any window of or otherwise wilfully damage any carriage. Any person acting in contravention of this Regulation shall be liable to the penalty prescribed by these Bye-laws and Regulations, in addition to the liability to pay the amount of any damage done.

8. A person whose dress or clothing might, in the opinion of the conductor of a carriage, soil or injure the linings or cushions of the carriage, or the dress or clothing of any passenger, or a person who, in the opinion of the conductor, might for any other reason be offensive to passengers, shall not be entitled to enter or remain in the interior of any carriage, and may be prevented from entering the interior of any carriage, and shall not enter the interior of any

carriage after having been requested not to do so by the conductor, and if found in the interior of any carriage, shall, on request of the conductor, leave the interior of the carriage upon the fare, if previously paid, being returned.

9. Each passenger shall upon demand pay to the conductor or other duly authorized officer of the Company, the fare legally demandable for the journey.

10. Each passenger shall show his ticket (if any) when required so to do to the conductor or any duly authorized servant of the Company, and shall also, when required so to do, either deliver up his ticket or pay the fare legally demandable for the distance travelled over by such passenger.

11. A passenger not being an artisan, mechanic, or daily labourer within the true intent and meaning of the Acts of Parliament relating to the Company, shall not use or attempt to use any ticket intended only for such artisans, mechanics, or daily labourers.

12. Personal or other luggage (including the tools of artisans, mechanics, and daily labourers), shall, unless otherwise permitted by the conductor, be placed on the front or driver's platform, and not in the interior or on the roof of any carriage.

13. No passenger or other person not being a servant of the Company shall be permitted to travel on the steps or platforms of any carriage, or stand either on the roof or in the interior, or sit on the outside rail on the roof of any carriage, and shall cease to do so immediately on request by the conductor.

14. No person, except a passenger or intending passenger, shall enter or mount any carriage, and no person shall hold or hang on by or to any part of any carriage, or travel therein otherwise than on a seat provided for passengers.

15. When any carriage contains the full number of passengers which it is licensed to contain, no additional person shall enter, mount, or remain in or on any such carriage when warned by the conductor not to do so.

16. When a carriage contains the full licensed number of passengers, a notice to that effect

shall be placed in conspicuous letters and in a conspicuous position on the carriage.

17. The conductor shall not permit any passenger beyond the licensed number to enter, or mount, or remain in or upon any part of a carriage.

18. No person shall enter, mount, or leave, or attempt to enter, mount, or leave any carriage whilst in motion.

19. No dog or other animal shall be allowed in or on any carriage, except by permission of the conductor, nor in any case in which the conveyance of such dog or other animal might be offensive or an annoyance to passengers. No person shall take a dog or other animal into any carriage after having been requested not to do so by the conductor. Any dog or other animal taken into or on any carriage in breach of this Regulation shall be removed by the person in charge of such dog or other animal from the carriage immediately upon request by the conductor, and in default of compliance with such request may be removed by or under the direction of the conductor.

20. No person shall travel in or on any carriage of the Company with loaded fire-arms.

21. No passenger shall wilfully obstruct or impede any officer or servant of the Company in the execution of his duty upon or in connection with any carriage or tramway of the Company.

22. The conductor of each carriage shall enforce, or prevent the breach of, these Bye-laws and Regulations to the best of his ability.

23. Any person offending against or committing a breach of any of these Bye-laws or Regulations shall be liable to a penalty not exceeding forty shillings.

24. The expression "conductor" shall include any officer or servant in the employment of the Company, and having charge of a carriage.

25. There shall be placed, and kept placed, in a conspicuous position inside of each carriage in use, a printed copy of these Bye-laws and Regulations.

26. These Bye-laws shall come into force on the 11th day of April, 1885.
